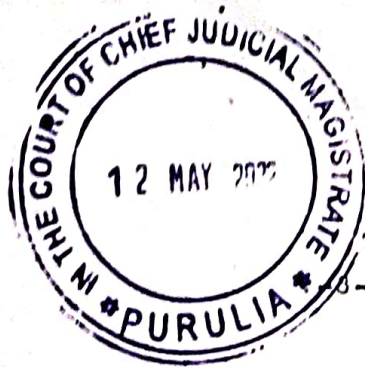
The humble petition on behalf of the
