3..That the deed of the complainant took away and other important documents which they fled away i.e. the important documents of the complainant and the complainant facing lot of trouble without the sale deed and other documents and they are also passing their days with tension and fear as because the said accused persons are dangerous and desparate in nature and they may caused any mischief and the lives and properties are danger of the complainant and his family members in the hand of the said accused persons.

It is therefore prayed that your Honour would be graciously pleased to admit this petition and treat it as F.I.R.

U/s 156(3) Cr.p.c. and send this petition before the Tamna P.S. for investigation matter the case and take proper step against the accused persons according to law.
