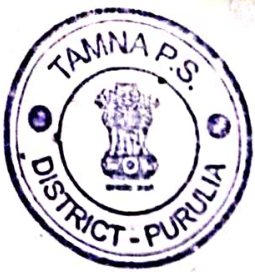

Respected Sir,

In producing herewith one arrested accused person namely Rampada Bauri (50 yrs) S/O- Late Kalipada Bauri of Vill- Kantasiyari, P.O- Ralibera, P.S- Tamna, Dist.- Purulia with seizure list and seized articles, I beg to submit that today i.e on 01.06.2022 at about 17:05 hrs during Evening mobile duty at PS area vide Tamna PS CC No- 3126/22 date- 01.06.2022 & Tamna PS GDE No- 33 date- 01.06.2022, received a secret source information and as per order of O/C Tamna PS, I ASI Chittaranjan Mukhopadhyay of Tamna PS along with force had been to Kantasiyari village under Tamna PS at 17:45 hrs and as per indication conducted raid in the house of Rampada Bauri S/O- Late Kalipada Bauri of Vill- Kantasiyari, P.O- Ralibera, P.S- Tamna, Dist.- Purulia and detained one person. On asking his identity he disclosed his identity as noted above. On interrogation he confessed his guilt for selling and possession of ID Liquor. On demand he failed to produce any valid documents in respect of stock and selling of ID Liquor at his house. As such I seized (i) One Plastic Jerican containing approx 10 (Ten) litres ID Liquor & (ii) one Plastic Bottle containing one litre ID Liquor taken from the Jerican for as a sample under proper Seizure List in presence of witnesses duly signed by witnesses and accused person. Arrested the above noted accused person on 01.06.2022 after observing all legal formalities regarding arrest. Informed him the ground of his arrest. The seized articles were properly sealed and label in presence of witnesses duly signed by them and accused person.

The above noted accused person namely Rampada Bauri (50 yrs) S/O- Late Kalipada Bauri of Vill- Kantasiyari, P.O- Ralibera, P.S- Tamna, Dist.- Purulia committed offence u/s- 46 A(c) B.E. Act- 1909 for unauthorized possession and sales of I.D Liquor from his house.

Under the fact and circumstances kindly take necessary lawful action against Rampada Bauri (50 yrs) S/O- Late Kalipada Bauri of Vill- Kantasiyari, P.O- Ralibera, P.S- Tamna, Dist.- Purulia.
