Sir,

In producing herewith the accused person namely Gourab Rajak (22 Yrs) s/o- Shyam Rajak of Vill- Manipith, Dhobiline, Ramdas Meal, Quarter No. 19, PS- Telko, Dist- East Singbhum, State- Jharkhand under proper memo of arrest along with related documents. Also one improvised country made iron made fire arms (having single barrel, butt, trigger and firing pin) having barrel Length- 4 and 1/2 inch approx. has been seized from his possession. In course of my anti-crime Evening-Night Mobile duty on 02/06/2022 at about 22:50 hrs I, PSI Surajit Kr. Das of Tamna PS received a source information that one trailer bearing Registration No. NL01G/5598 has been theft from Kandra, Saraikela, Kharsawa under Jharkhand State and coming towards Purulia. Then and there myself along with force started Naka Checking at Chengi More under Tamna PS, Dist- Purulia. Then on 03/06/2022 at about 00:35 hrs we intercepted and detained the said theft trailer bearing Registration No. NL01G/5598 with its driver. On being interrogation, the driver of the said trailer disclosed his identity as Bikash Yadav (26 Yrs) s/o- Lt. Balram Yadav of Vill+ P.S- Shahganj, Dist- Jaunpur, State- Uttar Pradesh A/P at Jemko Basti, Near Bike Service Centre, PO+PS- Telko, Dist- East Singbhum, State- Jharkhand. Also he disclosed that one helper named as Gourab Rajak of Telko, East Singbhum, Jharkhand was with him who got out of from the said theft trailer before some times. Afterthat myself along with force and said Bikash Yadav arrived at PS with the said theft trailer bearing Registration No. NL01G/5598 and kept it at the safe zone of Tamna PS compound under Dist- Purulia. Then myself along with force left PS with said Bikash Yadav to find said Gourab Rajak of Telko, East Singbhum, Jharkhand. It is to be noted here that a FIR has been lodged at Kandra PS, State- Jharkhand regarding this theft vide Kandra PS Case No. 48/22 dated- 03/06/2022 U/S- 395/506 IPC.

On being search while myself along with force and said Bikash Yadav reached at Karamara Bus Stand under Tamna PS, Dist- Purulia at about 11:15 hrs, as per identification of said Bikash Yadav, myself along with force detained one person. But seeing the police party he fled away. After a hot chase we able to intercept him near Karamara Bus Stand under Tamna PS, Dist- Purulia beside Purulia – Tata pitch road. Then I asked his name and address which is noted above. After that we started searching him but he refused to search. On searching I recovered the above mentioned fire arms from his waist. On asking he failed to produce any valid documents and papers in favour of that fire arms. He also failed to give satisfactory answer for keeping this fire arms in his possession. So, I seized the said fire arms under proper seizure list which was duly signed by the accused person. After the seizure I arrested the accused person observing all legal formalities as laid down by Hon'ble Supreme Court regarding the arrest of Gourab Rajak (22 Yrs) s/o- Shyam Rajak of Vill- Manipith, Dhobiline, Ramdas Meal, Quarter No. 19, PS- Telko, Dist- East Singbhum, State- Jharkhand comes under per view of Indian Arms Act. After that myself along with force, the detained said Bikash Yadav and arrested accused person with seized articles returned to PS.

I therefore pray to kindly start a specific case against the above noted accused person under proper section of law and arrange for proper investigation.
