Respected Sir,

I, SI Badal Paramanik of Tamna PS along with force returned to PS and brought one seized Red Colour MAHINDRA YUVO 415DI Tractor bearing Registration No- WB55B/4318 along with sand (Approx 100 cft.) loaded trolley and lodged this complaint to the effect that on 05.06.2022, myself along with i) C/2850 Subrata Panda and ii) C/3003 Tapas Duley were performing PS area mobile duty vide Tamna PS CC No. 3266/22 Dated- 05/06/2022. During my mobile duty on 05/06/2022 at about 17:15 hrs received credible source information that one Red Colour Tractor is lifting sand illegally from Kansai Riverbed at Doldari Sand Ghat under Tamna PS, Dist- Purulia. Accordingly, myself along with force left to work out the said source information. Then, we intercepted the aforesaid tractor at Doldari Sand Ghat under Tamna PS, Dist- Purulia at about 17:45 hrs and found that the above noted tractor was tagged with a trolley loaded with sand (approx 100 cft.). But seeing the Police party, driver and others of the tractor fled away leaving the said tractor with sand loaded trolley at Doldari Sand Ghat under Tamna PS, Dist- Purulia. We tried to apprehend them but failed. So, there is every ground to reason to belief that the owner and driver and others of above noted tractor dealing in sand business in clandestine manner. We waited for reasonable time but none came forward and produce any proper, challan or any valid documents related to the said loaded sand of above detained tractor. So, I seized the said Red Colour MAHINDRA YUVA 415DI Tractor bearing Registration No- WB55B/4318 along with sand (Approx 100 cft.) loaded trolley.

On return to Tamna PS, kept the aforesaid seized tractor attached with sand loaded (Approx 100 cft.) trolley at PS compound and I do here by submitting written complaint before you to start a cog case against the owner and driver and others of the tractor Registration No- WB55B/4318 under proper section of law.
