Respected Sir,

In producing herewith one arrested accused person namely Shibaram Mahato (52 yrs) S/O- Late Lalu Mahato of Vill- Banshradih , P.S- Tamna, Dist.- Purulia with seizure list and seized articles.

I beg to submit that i.e on 10.06.2022 at about 10:05 hrs during special mobile duty at PS area vide Tamna PS GDE No- 442 date- 10.06.2022, received a secret source information and as per order of O/C Tamna PS, 1 SI Hemanta Kumar Sahababu of Tamna PS along with C/1509-Animesh Mukherjee and NVF/635-Dhiren Dawn had been to Chitora more under Tamna PS at 13:45 hrs and as per indication conducted raid in the house of Shibaram Mahato (52 yrs) S/O- Late Lalu Mahato of Vill- Banshradih , P.S- Tamna, Dist.- Purulia and detained one person. On asking his identity he disclosed his identity as noted above. On interrogation he confessed his guilt for selling and possession of Foreign Liquor & ID Liquor. On demand he failed to produce any valid documents in respect of stock and selling of Foreign Liquor as well as ID Liquor at his house. As such I seized (1) Officer Choice - 05 bottles@180ml each (2) McDowell's No.1-08 bottles@180ml each (3)Imperial Blue-06 bottles @180ml each (4)Haywards 5000(Beer)- 10 bottles @650ml each (5)Bumper 70UP-04 bottles @300ml each (6)Bazigar 70UP-34 bottles@300ml each & (7) ID Liquor 30 Ltr. in a Jerican from which 01 ltr. taken in a plastic bottle as a sample under proper Seizure List in presence of witnesses duly signed by witnesses and accused person. Arrested the above noted accused person on 10.06.2022 after observing all legal formalities regarding arrest. Informed him the ground of his arrest. The seized articles were properly sealed and label in presence of witnesses duly signed by them and accused person.

The above noted accused person namely Shibaram Mahato (52 yrs) S/O- Late Lalu Mahato of Vill- Banshradih , P.S- Tamna, Dist.- Purulia committed offence u/s- 46 A(c) B.E. Act- 1909 for unauthorized possession and sales of Foreign Liquor as well as I.D Liquor from his house.

Under the fact and circumstances kindly take necessary lawful action against Shibaram Mahato (52 yrs) S/O- Late Lalu Mahato of Vill- Banshradih , P.S- Tamna, Dist.- Purulia.
