Sir,

In producing herewith one seized Motor Cycle having Registration No. WB56D-2183, Chassis No. 07E16F08508 & Engine No. 07E15E28384. The fact of the case in brief is that on 14/06/2022, I along with C/3003 Tapas Duley and C/1454 Ashoke Mahata of Tamna PS were on evening mobile duty. During evening mobile duty acting on a source information on 14/06/2022 at about 19.45 hrs. when we reached near at Baligara Nadighat found some unknown persons loaded the sand in a tractor from Kansai river. On seeing the Police party all the unknow persons and driver of the said tractor escaped from there after unloading sand approx. 70 Cft. and keeping the above noted motor cycle. We also trying to trace out the registration number of said tractor but due to long distance we are unable to trace out. It is ascertained that the owner and driver of the said tractor and others unknown persons loaded the said sand by illegal manner for selling the same to make profit by dishonestly in a clandestine business. So, seized the motor cycle having Registration No. WB56D-2183, Chassis No. 07E16F08508 & Engine No. 07E15E28384 and sand approx. 70 Cft. under proper seizure list in presence of available witnesses duly signed by them. Arrange the vehicle from my own source and brought the seized sand and motor cycle at PS.

Under the above facts and circumstances kindly take lawful action against the owner and driver of the Tractor and other unknown persons.
