Sub: To lodge FIR against owners and drivers of 03 (three) tractors viz (i) One Sonalika DI-35 tractor having reg. No. WB55B-3029 along with trolley (ii) One Mahindra B275 DI tractor having Reg. no. WB55B/4518 along with trolley and (iii) One New Holland tractor having Eng. No. 11937EDS4 & Chassis no. NHN30320ZFG327006 along with trolley (sand approx 60 CFT each trolleys).

Sir.

In producing herewith, 03 (three) tractors viz (i) One Sonalika DI-35 tractor having reg. No. WB55B-3029 along with trolley (ii) One Mahindra B275 DI tractor having Reg. no. WB55B/4518 along with trolley and (iii) One New Holland tractor having Eng. No. 11937EDS4 & Chassis no. NHN30320ZFG327006 along with trolley (sand approx 60 CFT each trolleys). Today on 19.07.2022 at about 12:25 hrs. acting on source information, I PSI Avijit Mondal of Arsha PS along with (i) C/-694 Nekibuddin Khan (ii) C/- 1140 Dayamay Mahato and (iii) C/- 109 Surjatapa Dolui all of Arsha PS left for PS area vide Spl. GDE No. 179/22 Dtd. 19.07.2022. After we reached at near Deulghata Bridge on the bank of Kanshai river under Arsha PS at 14.15 hrs, we conducted raid Deulghata Bridge on the bank of Kanshai river under Arsha PS and found that 03 (three) tractors along with trolleys attached with by a hinge was present at Deulghata Bridge on the bank of Kanshai river. Some persons were loading sand in the attached trolleys of said tractors. Seeing the Police party, those persons leaving the tractors (loaded with sand in the attached trolley) at Deulghata Bridge on the bank of Kanshai river, fled away. Police rushed to the tractors and detained the said tractors. Police searched the said tractors and found that the tractors are loaded with sand and also searched surrounding but could not trace out the persons & drivers of said offending tractors. On 28.06.22 District Magistrate, Purulia has passed an Order vide Memo No. VI/430(Part-VIII)/1707/54/M/17 Dt. 28.06.2022 that sand mining or extraction from any riverbed of the District of Purulia will remain temporary suspended for the monsoon season with effect from 01.07.22 to 30.09.22, until further order. Hence, I seized the above noted tractors along with trolleys and brought the tractors to Arsha PS. As there is every reason to believe that the drivers and owners of the said tractors with ill motive were transporting sand illegally without any valid document in support of carrying sand and violating the Govt. order they are doing such illegal activity.

Hence, I do hereby lodge this complaint against the owners and drivers of above noted seized tractors along with the trolleys for investigation.
