Sir,

I, Amaresh Das, Sub-Inspr. of Police, DEB, Purulia, do here by lodge complaint being produced the following seized articles (i) 03 (three) domestic LPG cylinders of HP Ltd. company fully loaded with LPG in sealed condition (ii) 02 (two) domestic LPG cylinders of Bharat GAS Ltd. company fully loaded with LPG in sealed condition (iii) 01 (one) empty LPG domestic Cylinder of HP company (iv) 01 (one) empty LPG domestic Cylinder of Bharat company (v) 01 (one) empty LPG domestic Cylinder of Indane company (vi) 02 (two) small domestic cylinder empty HP company (vii) 01 (one) nozzle device size 08 inch approx to have been made of iron (viii) 03 (three) nozzle device size (03 inch approx) appearing to have been made of copper used for re-filling gas from one to another cylinders to the effect that today on 05.07.2022 on the basis of secret and credible information I, along with ASI Swapan Chakraborty, C/88 Pradyut Mandal and HG/1427 Benimadhab Char had been to Arsha PS and submitted one requisition to O/C Arsha PS for rendering assistance and noted the information at Arsha PS vide Arsha PS GDE No.173 dtd. 05.07.2022 at 12.15 hrs. Thereafter we along with ASI Nivas Ch. Mahato and force of Arsha PS left for Palpal more under Arsha PS to work out the information. On arrival at Palpal more at about 12:35 hrs, I asked to local people viz. (1) Santipada Gorai S/O Lt. Sarbar Gorai of Palpal, PS- Arsha, Dist- Purulia to assist us with a view to work out the credible information also for holding raid, search and seizure in the house cum shop of one Bhairab Ch. Kumar s/o Lt. Bhudar Ch. Kumar, vill. Palpal, PS Arsha, Dist Purulia. Prior to holding raid in the house cum shop, we noticed huge nos. of domestic LPG cylinder kept inside the house cum shop along with apparatus which is being used for refilling LPG from big cylinder to small cylinder. The owner namely Bhairab Ch. Kumar s/o Lt. Bhudar Ch. Kumar, vill. Palpal, PS Arsha, Dist Purulia was asked to produce valid document/license for running his business in respect of processing such domestic LPG cylinder and also such business of re-filling, but the owner Bhairab Ch. Kumar failed to produce any valid document/license for running such illegal business. Thereafter I seized the above noted articles in between 13.15 hrs to 13.45 hrs. with proper leveling in presence of police witnesses under proper seizure and observing all formalities relating to search and seizure.

Bhairab Ch. Kumar s/o Lt. Bhudar Ch. Kumar, vill. Palpal, PS Arsha, Dist Purulia failed to produce any valid document/ papers for running such business,


In course of local enquiry it revealed that said Bhairab Ch. Kumar is running such clandestine business of LPG Gas Cylinder and also selling LPG after refilling in other cylinder since long without having any authority or license, only for causing his wrongful gain and causing loss of revenue to Govt. Hence he violated provisions laid in rule 3 of West Bengal cooking Gas (Licensesing & control order) 1985.

The above noted seized article as mentioned in Sl. No. 01 to 06 left in Zimma to one proprietor namely Adhar Ch. Kumar S/O Bholanath Kumar of Vill- Karandih, PS- Arsha, Dist- Purulia vide his dealer code No. G/EC/WB/06/1458 (G40041) in anticipatory of approval of the Ld. C.J.M, Sadar Court Purulia.

I therefore, pray before you the start a case U/S 7(1)(a)(ii) of E.C. Act (X)1955 against accused Bhairab Ch. Kumar s/o Lt. Bhudar Ch. Kumar, vill. Palpal, PS Arsha, Dist Purulia.

As per order of S.P. (DEB) Purulia, Purulia ASI Prabir Mukherjee of DEB, Purulia will investigate the case.
