Ram Singh of Vill Kantadih near Kantadih Vati morh, PS- Arsha, Dist- Purulia along with 72 seized Mobile phones (Details in seizure list) seized under proper seizure list and memo of arrest in respect of the 04 (four) accused persons before you.

The nub of the fact in a nutshell is that today 13.07.2022 while I along with force namely 1) C/1516 Arnab Sinha of Arsha PS 2) C/223 Kamakshya Majee 3) C/239 Kajal Kuiry 4) C/264 Bijan Biswas all of SAP 7<sup>th</sup> BN camp at Arsha PS were performing patrolling duty vide Arsha PS CC No 1428/22 Dated 13.07.2022 and Arsha PS GDE no 496 Dated 13.07.2022 at Kantadih area on Purulia-Balarampur road. During my patrolling duty, I received a tip off at 15.35 hrs that some stolen mobiles are kept at Kantadih Gulgulia Basti. After informing O/C Arsha PS I along with force went to Kantadih Bazar near Sishu Bharati School at 15.55 hrs. As per identification of source I held raid at the house of Suraj Mali and found 14 (fourteen) Nos of mobile phones viz (1) One sky blue colour One plus mobile phone having model no. I seized said these 14 Mobile Phones from the exclusive possession of accused Suraj Mali under proper seizure list duly signed by Police witnesses and also by the accused person. I prepared label for the seized items and I took signature of accompanied force in the seizure list and label. Nobody turned up as public witness to sign in the seizure list and label. After that I arrest the above noted accused person observing all the rules and guidelines of Apex court and NHRC. The whole process was done in between 16.15 hrs and 17.10 hrs.

The whole process was done in between 17.25 hrs and 18.40 hrs.

After that I arrest the above noted accused person observing all the rules and guidelines of Apex court and NHRC. The whole process was done in between 18.55 hrs and 20.00 hrs.

I seized said these 18 Mobile Phones from the exclusive possession of accused Bhagirath Singh under proper seizure list duly signed by Police witnesses and also by the accused person. I prepared label for the seized items and I took signature of accompanied force in the seizure list and label. Nobody turned up as public witness to sign in the seizure list and label. After that I arrest the above noted accused person observing all the rules and guidelines of Apex court and NHRC. The whole process was done in between 20.25 hrs and 21.40 hrs.

As they illegally theft/received and possessed above noted 72 (seventy two) Mobile Phones to use those for unlawful purpose. So, after returning at PS, I produced the 04 (four) arrested accused persons along with the seized 72 (seventy two) Mobile Phones with all relevant papers before you.

Under the above circumstances, I therefore pray that a case may kindly be started under proper sections of law against the arrested accused persons namely 1. Suraj Mali (34 yrs) S/O Motilal Mali 2. Shakti Mali (32 yrs) S/O Motilal Mali 3. Suryadeb Singh (18 yrs) S/O Lt. Ganguram Singh all of Vill- Kantadih morh near Sishu Bharati School, PS- Arsha, Dist- Purulia and 4. Bhagirath Singh (22 yrs) S/O Lt. Ram Singh of Vill Kantadih near Kantadih Vati morh, PS- Arsha, Dist- Purulia and to arrange for its investigation.
