Sir,

In producing herewith one seized red colour Mahindra B275 DI tractor having Reg No-WB55B/2906 along with sand loaded trolley under proper seizure list, I beg to submit that today on (05.07.22) I along with (1) C/1355 Rajib Banerjee (2) C/2228 Pradip Lohar, 3) C/2969 Soumen Hatul of Suisa OP under Baghmundi P.S were performing special mobile duty vide Suisa OP CC No-645/2022, Date-05.07.2022. During my special mobile duty at about 18:45 hrs I received a source information that a suspicious tractor loaded with sand was coming from Marcha side. I informed this matter to I/C Suisa OP and after getting necessary permission I along with force left for the said place.

While I along with force arrived at Saridih village More at 19:15 hrs, found that one tractor was coming from Marcha side and seeing the Police party the driver of the said tractor fled away leaving the said tractor. Following the driver of the Tractor, myself along with two constables namely C/1355 Rajib Banerjee (2) C/2228 Pradip Lohar, (leaving the other constable 2969 Soumen Hatul near tractor as guard) started chasing the driver. Due to the darkness and the topography, the driver of the said vehicle somehow managed to escape in a suspicious manner.

In the mean time, taking advantage of being under strength, one Amulya Kumar S/O-Tarani Kumar of village-Marcha PS-Bagmudi reached near the sand loaded Tractor and shouting towards the constable 2969 Soumen Hatul. When constable 2969 Soumen Hatul intervened, he, all of a sudden, started pushing the constable saying "who dare you authorize to detain the Tractor, the Tractor belongs to me and I shall take it away by hook or crook". Considering the situation, the constable 2969 Soumen Hatul tried to calm him down and asked him to produce valid paper in respect of the sand loaded in the Tractor. But, instead of producing any valid paper, he got furious, and punctured the tyre of the Tractor pushing the constable 2969 Soumen Hatul down. At the same time, we were returning after the chase and seeing us getting back, Amulya Kumar fled away from the spot. Such activities of Amulya Kumar was to deter the Police party from discharging our bona fide Govt. duty and to restrain the Police party from taking custody of the illegal sand.

Due to such suspicious activity of the driver and Amulya Kumar it was ascertained that the driver of the said tractor in connivance with Amulya Kumar loaded the sand with the consent of the owner of the vehicle by illegal means for selling the same to make profit by dishonestly and he had been running a clandestine business, hence it is reasoned to belief that the driver of the vehicle procured the said sand from Subarnarekha river bed by fraudulently means or theft by any means. Hence, I seized the tractor vide Reg No-WB55B/2906 along with sand loaded trolley in between 19:55 hrs to 20:25 hrs under proper seizure list duly signed by witnesses. I brought the said sand loaded tractor to Baghmundi P.S compound as such there is every reason to believe that the driver, owner and Amulya kumar s/o-Tarani kumar of Marcha with ill motive were dealing with sand illegally without any valid document.

It is to mention worthy that sand mining/extraction from any riverbed of the District of Purulia has been temporarily suspended for the monsoon season from 01.07.22 to 30.09.22 by the District Magistrate & Collector Purulia vide memo no-VI/430(part-VIII)/1707/54/M/17 dated-28.06.22.

Therefore, I pray before you that a case may kindly be started and arrange for its investigation.
