**Sub- Prayer to start FIR**

I SI Subrata Sarakar, O/C Suisa OP under Baghmundi PS do here by lodge a written complaint to the effect that today at 07:55 hrs received a telephonic information that an unknown dead body has been found buried underneath the surface of Subarnarekha River near the Saldabra village under Baghmundi PS. Accordingly, I diarized the matter vide Suisa OP GDE No- 172, Dtd: 07.07.2022 & subsequently informed the matter to O/C Baghmundi PS, Thereafter, myself along with SI Sourav Kanti Das, C/22 Asish Molla, C/1355 Rajib Banerjee vide C.C No-655, Dtd: 07.07.2022 & GDE No-176, Dtd: 07.07.2022 left to work out the information. On reaching the PO as noted above, I cordoned off the area properly in order to ensure no tempering of evidences.

By that time, requisition sent to S.D.O Jhalda to depute an Executive Magistrate for exhuming the dead body. Thereafter, Sri Debraj Ghosh, Executive Magistrate, B.D.O Baghmundi was deputed for exhumation. As per direction of executive magistrate, the dead body was exhumed under video graphy. Later on, the dead body was identified as Parikhit Sing Mura, S/O-Bhasrath Sing Mura of Vill-Gagi, PS-Baghmundi, Dist-Purulia. After exhuming the dead body, the executive magistrate observed the following injuries over the dead body i) Deep holes were noticed in right chick and chin, ii) Deep wound mark also present in right back side of neck. Considering the injuries present over the dead body, there is no doubt that the death is unnatural, hence, started Baghmundi PS UD Case No-23/2022, Dtd: 07.07.2022. SI Sourav Kanti Das was endorsed to investigate the UD case U/S-174 Cr. P.C.

On completion of the inquest U/S-174 Cr.P.C the injuries observed by the E.O. SI Saurav Kanti Das as deep cut wound in right back side neck.

On record injuries found on the dead body suggest that some unknown persons murdered Parikhit Sing Mura and buried the body underneath the surface of Subarnarekha River near Saldabra village with a view to conceal the evidences.

Hence, I pray to start a specific case over this instance & arrange for its investigation.
