On 20/07/2022 at about 12:30 p.m. I Sri Swapan Kumar Das, AE & Station Manager, Bagmundih CCC along with 1. Sri Subhasis Mahato, Sr. O.E., Bagmundi CCC 2. Sajal Kumar Mahanty, Sr. O.E. Bagmundi CCC, entered the premises of Sri Durlab Kuiry, S/O- Nabo Kuiry of Village Tunturi, P.O.- Suisa, PS- Bagmundi, Dist- Purulia and found Sri Durlab Kuiry was enjoying electricity unauthorziedly drawing power from the nearest L & MV line of WBSEDCL through PVC wire by means direct hooking to his house premises and connected load found 0.15 KVA. As Sri Durlab Kuiry S/O- Nabo Kuiry committed theft of electric power, So, I seized the following articles after preparing the seizer list in presence of 1. Sri Subhasis Mahato, Sr. O.E. 2. Sajal Kumar Mahanty, Sr. O.E. . The inspection team left the premises at 12:45 p.m.
