Sub: Complaint against Dilip Gorain (30 Yrs) S/o- Shyamapada Gorain of Vill- Bhagabandh, PO- Routora, PS- Barabazar, Dist- Purulia to start a specific case under proper section of Law.

Sir,

In producing here with arrested accused person namely Dilip Gorain (30 Yrs) S/o- Shyamapada Gorain of Vill- Bhagabandh, PO- Routora, PS- Barabazar, Dist- Purulia and seized one Plastic Jarokin containing about 11 (Eleven) Liters liquor (ID, Cholai) on which half liters taken as sample from said Jarokin as per enclosed seizure list.

I, ASI Manas Kumar Pan of Barabazar PS do here by lodge this complaint against Dilip Gorain (30 Yrs) S/o- Shyamapada Gorain of Vill- Bhagabandh, PO- Routora, PS- Barabazar, Dist- Purulia. I beg to state that on 26.07.2022 myself along with C/- 1182 Santosh Kumar Mahato & C/- 1211 Chunaram Hembram were left for evening mobile duty vides Barabazar PS GDE No- 1868 Dtd. 26.07.2022. During my evening mobile duty at about 19.25 hrs I received information that one person was selling liquor in his house at Bhagabandh village under Barabazar PS. I was there to verify the credibility of that information and immediately informed the I.C Barabazar PS. As per direction of I.C Barabazar PS myself along with forces had been to the said place to work out the information. At about 19.55 hrs myself along with force held a raid in the dwelling house of Dilip Gorain at Bhagabandh village and found that one person selling Liquor (Cholai) in his house. Seeing the Police party buyers fled away, but we apprehended the house owner who was selling the Liquor. On search I found one Plastic Jarokin containing about 11 (Eleven) Liters liquor (ID, Cholai) in his dwelling house. On demand, he failed to produce any valid documents / License in respect of keeping & selling liquors (ID, Cholai). On being asked he confessed his guilt and stated that he was selling the liquors (ID, Cholai) from his house to the local peoples with intent to make his own profit. He disclosed his identity as Dilip Gorain (30 Yrs) S/o- Shyamapada Gorain of Vill- Bhagabandh, PO- Routora, PS- Barabazar, Dist- Purulia. He also admitted that he has no license or any authorization for keeping or selling of liquors (ID, Cholai). Accordingly, I seized the above noted Liquor after preparing proper seizure list and put label on the seized articles in presence of witnesses and on which half liters taken as sample from said Jarokin which were also duly labeled by me and also took signature of the accompanying witness on seizure list and label as well as accused person also. The seizure and label was done in between 20.05 hrs and 20.45 hrs. Thereafter, I arrested the accused person namely Dilip Gorain (30 Yrs) S/o- Shyamapada Gorain of Vill- Bhagabandh, PO- Routora, PS- Barabazar, Dist- Purulia after preparing Memo of Arrest & after observing all other formalities regarding arrest as per Cr.PC and NHRC guideline. Accordingly, informed him and his family members regarding the grounds of arrest. The arrest was made on 26.07.2022 at 19.55 hrs.

Under the above fact & circumstances I therefore, pray before you that a specific case may kindly be registered against the arrested accused person namely Dilip Gorain (30 Yrs) S/o- Shyamapada Gorain of Vill- Bhagabandh, PO- Routora, PS- Barabazar, Dist- Purulia under proper section of Law.
