Sir,

In producing herewith arrested accused person namely Sahid Dalal (28yrs) S/O-Ganu Dalal of Vill- Kusumbani , PO- Bishnupur, PS- Bishnupur, Dist- Bankura, along with one seized Tata Pickup van bearing Registration No-WB67C/0432.

I beg to report that today myself along with C/1246 Shaktipada Mahato, C/253 Arabinda Mallik, all are of Boro PS were performing Naka checking duty at Burudih more under Boro PS area vide Boro PS C.C No-1702/22 dtd.04.07.2022 and Boro PS GDE No-148 dtd- 04.07.2022. At about 19.55 hrs, I found one Tata Pickup van bearing Registration No-WB67C/0432 coming from Bandwan side rashly and negligently. We try to stop him but the driver of the said vehicle named in above was trying to escape the place so rashly, there was every possibility of loss/ serious injury of nearby public due to his such driving. Somehow we could able to stop him. On being asked, he stated his name and address as noted above, but unable to give any satisfactory account for his such rush and negligent driving which may cause endanger to human life. So, I arrested him as he violated Sec. 279 IPC. I also seized the Tata Pickup van in presence of witnesses. His family member was also informed about the ground of arrest.

Therefore I pray that a specific case may kindly be started against the accused Sahid Dalal (28yrs) S/O-Ganu Dalal of Vill- Kusumbani , PO- Bishnupur, PS- Bishnupur, Dist- Bankura.
