In producing herewith arrested accused person namely Sibub Sing Sardar (55 years) S/O- Kishan Sing Sardar of Vill- Sirishgora , PS- Bandwan, Dist- Purulia, along with one seized Tractor bearing Registration No-WB55A – 6074 (Mahindra 475 DI).


I beg to report that today myself along with C/974 Dilip Kr. Ghosh, C/1202 Swapan Roy, all are of Boro PS were performing Naka checking duty at Kallabera more on Kuilapal – Bandwan pitch road under Boro PS area vide Boro PS C.C No-1816/22 dtd.16.07.2022 and Boro PS GDE No-678 dtd- 16.07.2022. At about 13.45 hrs, I found one Tractor bearing Registration No-WB55A – 6074 (Mahindra 475 DI) was coming from Kuilapal side towards Bandwan side rashly and negligently. We try to stop him but the driver of the said vehicle named in above was trying to escape from the checking place with tractor, there was every possibility of loss/ serious injury of nearby public due to his such driving. Somehow we could able to detain the tractor with driver. On being asked, he stated his name and address as noted above, but unable to give any satisfactory account for his such rush and negligent driving which may cause endanger to human life. On demand he could not produce his driving license. So, I arrested him as he violated Sec. 279 IPC & 181 M.V. Act. 1988. I also seized the Tractor in presence of witnesses. I informed him ground of arrest as well as informed his family members regarding his arrest.

Therefore I pray that a specific case may kindly be started against the accused driver Sibub Sing Sardar (55 years) S/O-Kishan Sing Sardar of Vill- Sirishgora , PS- Bandwan, Dist- Purulia.


