In producing herewith one seized vehicle i.e Tractor Mahindra Model- B 275 DI TU MKM DLX having Chasis No-MBNABAEAKHRC00745 & Engine No- RHC2EAN3336 fitted with Trolley (without number plate) loaded with sand (approx 100 cft.). The fact of the case in brief is that on 10.07.2022 I SI Jayanta Chakraborty of Hura P.S along with HG/1535 Pravash Ruhidas, NVF/99 Bimal Gorai of Hura PS were on Spl. mobile duty on Kulgora-Keshargarh road vide Hura PS Spl. CC No- 336/22 Dtd- 10.07.2022. During mobile duty today (10.07.2022) at about 06.05 hrs received credible source information that some persons procured sand illegally and loaded their Tractor at Kansai river near by Konapara ghat under Hura PS. After receiving this information and as per getting permission of O/C Hura PS I had been to the spot at about 6.45 hrs and found that the above noted tractor standing the spot loaded with sand in a trolley, seeing police party the driver of the above noted tractor fled away from the spot. We searched for any valid documents in respect of sand loaded in the tractor as well as the valid documents in respect of that tractor but nothing was found. Hence I seized the said Tractor i.e Mahindra Model- B 275 DI TU MKM DLX having Chasis No-MBNABAEAKHRC00745 & Engine No-RHC2EAN3336, fitted with Trolley (without number plate) loaded with sand (approx 100 cft.) under proper seizure list in presence of available witnesses duly signed by them in between 06.55 hrs. and 07.35 hrs. Thereafter arranging a driver from my source I brought the said tractor to Hura P.S. As such there is every reason to believe that the driver and owner of the Tractor Mahindra Model- B 275 DI TU MKM DLX having Chasis No-MBNABAEAKHRC00745 & Engine No- RHC2EAN3336, fitted with Trolley (without number plate) with ill motive to procured the sand from the Kansai river near by Konapara ghat and they are transporting said sand illegally without any valid document . So they are liable for offence punishable U/S-379/411/414 IPC & 21 (1)(4) Mines and Minerals (R&D) Act-1957.

Therefore, I pray before you that a case against the driver and owner of Tractor Mahindra Model- B 275 DI TU MKM DLX having Chasis No- MBNABAEAKHRC00745 & Engine No-RHC2EAN3336, fitted with Trolley (without number plate) may kindly be started and arrange for its investigation.
