
In producing herewith arrested accused Kishore Gope (46 yrs.) S/O-late Joti Gope of Vill- Chakaltor, PS- Tamna Dist-Purulia, along with seized vehicle No. NL01AE -1720 (Truck) loaded with iron ore I beg to report that on 11.7.2022 I SI Jayanta Chakraborty along with C/877 Basudev Mahato, C/1052 Shyamlal Murmu and NVF 908 Lakhindar Singh Mura all of Hura PS were performing night mobile duty vide Hura PS C.C No - 1569/22 dtd. 11.7.2022 and Ref. Hura PS GDE No. 511 Dtd-11.7.2022 while we reached at Hura Bazar under Hura PS area at about 22.15 hrs. We found one Truck having Registration No NL01AE -1720 was coming from Purulia side towards Bankura side with rash and negligently. We tried to stop him but the driver of the said vehicle named noted above was trying to escape the place dangerously, there was every possibility of loss/ serious injury of nearby public due to his such dangerous driving. After a hot chase we could be able to stop him at Samukgoria near Pather Sathi Motel (NH60A) under Hura PS, Purulia at about 22:35 hrs. On being asked, he stated his name and address as noted above, but unable to give any satisfactory account for his such rush and negligent driving which may cause endanger to human life and also found as per his attitude it is clear that he was driving the vehicle with drunken condition. On demand he produced all Xerox documents in respect of the said vehicle and stated that original kept before owner of vehicle. Accordingly, I seized the above noted vehicle loaded with iron ore by preparing seizure list (details are mentioned in the attached seizure list) with a view to prosecute him U/S 279 IPC and 184/185 MV Act 1988. The whole process of seizure was completed in between 22:55 hrs and 23:10 hrs. I also arrested driver of the said vehicle as he violated sec 279 IPC and 184/185 MV Act in presence of Police party. During the time of arrest maintained all formalities regarding arrest. The driver was medically checkup at Hura Rural Hospital where medical officer opined the patient fully drunken.

Hence I pray that a specific case U/S 279 IPC and 184/185 MV Act 1988 may kindly be initiated against accused Kishore Gope (46 yrs.) S/O-late Joti Gope of Vill- Chakaltor, PS- Tamna Dist-Purulia, driver of vehicle No. NL01AE -1720 (Truck) and arrange its investigation.
