Sir,

In producing herewith one seized vehicle i.e Tractor ACE DI-350 NG having registration no- WB55A/6829 fitted with Trolley (without number plate) loaded with sand (approx 100 cft.). The fact of the case in brief is that I ASI Narayan Mukharjee of Hura P.S along with C/1580 Alam Ansary, NVF/264 Sanjoy Mahato of Hura PS were on Day mobile duty on Purulia- Bankura NH60A road vide Hura PS CC No- 1607/22 Dtd- 16.07.2022. During mobile duty on 16.07.2022 at about 15:05 hrs received credible source information that the above noted (Tractor) is coming from Kashipur side loaded with sand. After receiving this information we were proceeding towards "Lalpur Morh" under Hura P.S. When we reached near "Lalpur Morh" under Hura P.S, found that the above noted (Tractor) was coming from Kashipur side. On seeing the Police party the driver of the said tractor stopped the tractor in a distance at Lalpur morh and tried to unload the sand loaded in the said tractor. We rushed to the tractor and the driver then fled away after keeping the tractor near "Lalpur morh" at 15:15 hrs. We searched the said tractor and found that the tractor is loaded with sand. I searched for any valid documents in respect of sand loaded in the tractor as well as the valid documents in respect of that tractor but nothing was found. Hence I seized the Tractor ACE DI-350 NG having registration no- WB55A/6829 fitted with Trolley (without number plate) loaded with sand (approx 100 cft.) under proper seizure list in presence of available witnesses duly signed by them in between 15:15 hrs. and 15:35 hrs. Thereafter arranging a driver from my source I brought the said tractor to Hura P.S. As such there is every reason to believe that the driver and owner of the Tractor ACE DI-350 NG having registration no- WB55A/6829 fitted with Trolley (without number plate) with ill motive are transporting sand illegally without any valid document in support of carrying sand. So they are liable for offence punishable U/S-379/411/414 IPC & 21 (1)(4) Mines and Minerals (R&D) Act-1957.

Therefore, I pray before you that a case against the driver and owner of Tractor ACE DI-350 NG having registration no- WB55A/6829 fitted with Trolley (without number plate) may kindly be started and arrange for its investigation.
