Dear Sir,

With due respect myself Dr. Kanchan Gaba wish to draw your kind attention that I am the secretary of Turnstone Global, an national repute organisation based in Kolkata.

To uplift the local education of children Turnstone Global runs a school named 'Turnstone Daulat Public School' since 2011 at vill. Belabahal, Bagdaha, Ladhurka, Pin-723148, Purulia which comes under your jurisdiction.

I, myself is in ~~in~~ monthly visit from Kolkata to disburse salary of the employees worked over here since 16th June 2022.

During my present stay a local goon named Mr. Sujit Banerjee a resident of Ladhurka met me on 17/07/22 & demand of Rs. 50,000 & job for her daughter which I denied. After denying to pay Rs. 50,000/- he threatened me stating that he will not allow us to run this school.

As days passed on after that day he started ~~disturb~~ creating chaos in school premises by procuring different vendors associated with the developmental

walk in our school premises.

Today while I was leaving my school premises at around 9am along with our CEO Dr. Satyam Dey by our car suddenly Mr. Sujit Boneyee along with our another staff Mr. Kalyan Chattopadhyay who is also a resident of Kadurwa came at our school mangate by riding a motorcycle driven by Mr. Kalyan Chattopadhyay & started abusing us & keep hitting on our car & threatened our school children stating that if they come to attend this school he will cut them & will attack them with bombs.

In such scenario, ~~we~~ all of our staffs including female teachers & students are get afraid & assuming some heinous crime may happen in this school premises. & ~~at~~ simultaneously myself get afraid & is assuming life threat in this area to continue my work.

Hence you are requested to consider this information as first information report against Mr. Sujit Boneyee (Mob. 8597044150) & Mr. Kalyan Chattopadhyay (mob: 8972498798)
