In producing here with 03 (three) arrested accused person namely 1) Islam Ansary (24 yrs) S/O Kiyam Ansary of Vill- Madhupur, PO- Brujapur, PS- Jhalda, Dist- Purulia 2) Aitullah Khan (30 yrs) S/O Mahasin Khan of Vill- Hossaindih, PS- Jhalda, Dist- Purulia and 3) Samiullah @ Kismat Khan (49 yrs) S/O Lt. Ajad Khan of Vill- Hossaindih, PS- Jhalda, Dist- Purulia and along with 03 (three) seized Motor Cycle- (i) One red black colour Achiver motor cycle having registration No- OD02AB-8559, Engine No- KC10EFGGD00254, Chassis No- MBLKC10ETGGD00290 (ii) One black yellow colour Super Splendor motor cycle Without Registration No having engine No- JA07ABMGD04387 chassis no MBLJAW17XMGD04561 (iii) One black red colour Hero HF Dulex motor cycle having registration No JH05AQ-5885, Engine No- HA11ENJHK14808, Chassis No- MBLHAR231JHK10590. The fact in brief is that today (05.07.2022) at 14:55 hrs received credible source information that 03 (three) persons with 03 (three) stolen motor cycle were coming from Gola side and proceeding towards Jhalda Town to deliver the stolen motor cycle. Subsequently, I informed you and noted the information in GD vide Jhalda PS GDE No 220 Dated 05/07/2022 and as per your gracious order. I along with force namely i) C/1284-Pratapaditya Majhi, ii) C2182 Md Saiful Khan, iii) C/240 Manaranjan Bagdi & iv) NVF/778-Samir Mahato all of Jhalda PS vide Jhalda P.S. GDE No- 221 Dated- 05/07/2022 in consonance with Jhalda PS CC No- 1792/22 Dated- 05/07/2022 left to work out this tipoff. I arrived at Mahatomara more and started Naka Checking after proper placing guard rail on the road. Thereafter I saw the three motor cycles were proceeding towards Jhalda town side. Consequently, we intercepted the said motor cycles at Naka checking point at about 16:05 hrs and found that those motor cycle as identical as I received prior information and also identified by the source. On being asked, the drivers of the said motor cycle disclosed their names noted in the supra. I asked them to produce the valid documents in respect of the motor cycles. But they could not able to produce any kind of documents in respect of the motor cycle. I repeatedly asked the drivers to produce the valid papers but they stated differently in different times. The incoherent statement of the drivers purported to be a suspicious to us. On interrogation they confess their guilt and said that they stole the motor cycle at Jharkhand and sell the said motorcycle at Jhalda PS and Koishila PS area. Ergo I, seized 03 (three) motor cycle (i) One red black colour Achiver motor cycle having registration No- OD02AB-8559, Engine No- KC10EFGGD00254, Chassis No- MBLKC10ETGGD00290 (ii) One black yellow colour Super Splendor motor cycle Without Registration No having engine No- JA07ABMGD04387 chassis no MBLJAW17XMGD04561 (iii) One black red colour Hero HF Dulex motor cycle having registration No JH05AQ-5885, Engine No- HA11ENJHK14808, Chassis No- MBLHAR231JHK10590 under proper seizure list in presence of available witnesses duly signed

by them and also arrested the driver of the motor cycles 1) Islam Ansary (24 yrs) S/O Kiyam Ansary of Vill- Madhupur, PO- Brajapur, PS- Jhalda, Dist- Purulia 2) Aitullah Khan (30 yrs) S/O Mahasin Khan of Vill- Hossaindih, PS- Jhalda, Dist- Purulia and 3) Samiullah @ Kismat Khan (49 yrs) S/O Lt. Ajad Khan of Vill- Hossaindih, PS- Jhalda, Dist- Purulia after informing the ground of arrest and issued Memo of arrest against them.. Thereafter, I brought those 03 (three) motor cycles to Jhalda PS compound.

Under the above facts and circumstances kindly take lawful action against the 1) Islam Ansary (24 yrs) S/O Kiyam Ansary of Vill- Madhupur, PO- Brajapur, PS- Jhalda, Dist- Purulia 2) Aitullah Khan (30 yrs) S/O Mahasin Khan of Vill- Hossaindih, PS- Jhalda, Dist- Purulia and 3) Samiullah @ Kismat Khan (49 yrs) S/O Lt. Ajad Khan of Vill- Hossaindih, PS- Jhalda, Dist- Purulia as they committed the offence U/S- 379/411/413/414/120B of the IPC.
