Sir,

In producing herewith 01 (One) arrested accused person namely Raju Saw (43) S/O Kinkar Saw of Jhalda Anandabazar, Ward No-02, PS-Jhalda, Dist-Purulia under arrest along with seized articles as per seizer list i.e. (i) 08 (Eight) Ltrs. ID Liquor (Cholai) in a Plastic Jarican (ii) 06 (Six) pieces of plastic bottles Country Sprit having 600 ML in each bottles printed as "Dil Khush" (iii) 20 pieces of plastic glass under proper seizure with label.

I PSI Habibur Rahman of Jhalda PS hereby lodged a written complaint against the above noted accused person to the effect that today (06/07/2022) myself along with (i)C/1284 Prapaditya Majhi (ii) C/2182 Md Safiul Khan (iii) NVF/778 Samir Ch Mahato (iv) HG/1807 Shyam Singh Laya all of Jhalda PS were performing anti crime evening mobile duty (This refers to Jhalda PS CC No. 1803/22 dated 06/07/2022 and GDE No. 266 dated 06/07/2022. During evening mobile duty at about 20:45 hrs I received a credible source information that the above noted accused person selling ID Liquor from his hotel styled as "Bishnu Hotel" situated at Birsamore on Jhalda Baghmundi Road, PS-Jhalda, Dist-Purulia . On receipt such information I immediately informed the matter to you and as per your kind direction I along with force proceeded to work out the information. We reached at Bishnu Hotel at Birsamore on Jhalda Baghmundi Road, PS-Jhalda, Dist-Purulia. at about 21:05 hours and held raid at "Bishnu Hotel" and found that the accused person namely Raju Saw (43) S/O Kinkar Saw of Jhalda Anandabazar, Ward No-02, PS-Jhalda, Dist-Purulia, owner of the hotel is selling ID Liquor from his hotel. Seeing the Police party the buyers are fled away. On searched (i) 08 (Eight) Ltrs. ID Liquor (Cholai) in a Plastic Jarican and (ii) 20 pieces of plastic glass were found there. On demand he failed to produce any license / authority of the said liquors. On interrogation he also made incoherent statement regarding possession of said liquors and told that he is usually selling the same to the villagers illegally. So, finding no any other alternative I seized the above noted articles from the possession of the accused persons and labelled, duly singed by the accused person & witnesses in between 21:35 hrs to 22:05 hrs in which 500 ML of ID Liquor (Cholai) in a bottle from mother sample and one piece of plastic bottle Country Sprit having 600 ML printed as "Dil Khush" were kept as sample with label. During interrogation he confessed his guilt as such I arrested him at 22:10 hrs after observing all the formalities as per law issuing memo of arrest as the accused person is liable for prosecution U/S-46A (c) of the Bengal Excise Act 1909.

I therefore pray that a specific Case may kindly be started against the accused person namely Raju Saw (43) S/O Kinkar Saw of Jhalda Anandabazar, Ward No-02, PS-Jhalda, Dist-Purulia U/S- 46A (c) of the Bengal Excise Act 1909.
