Respected Sir,

In producing herewith one arrested accd namely Salim Ansary (41 yrs) S/O Lt. Gul Mohammad Ansary of Vill-Bandulohar, PO-Mahatomara, PS-Jhalda, Dist- Purulia and seized articles viz. i) one Iron made improvised 7.65 mm pistol loaded with one magazine in which the length of barrel approx 5.9 inch and length of butt approx 3.5 inch in which the firing pin is present and ii) Two round live 7.65 mm. ammunition and it was loaded in magazine of Sl. No-1 iii) One Black & Green colour TVS sport motor cycle having registration no-JH09H9266 Chassis No-MD625MF54D1A72075, Engine No-CF5AD1827792 under proper seizure list. I, A.S.I Krishnapada Gorain beg to inform you that today (10/07/22) at 17:15 hrs during my evening mobile duty with force namely (i) C/1207 Tarit Kr. Majhi, (ii) C/1284 Pratapaditya Majhi, (iii) NVF/843 Bibekananda Mahato and (iv) NVF/1036 Parmatha Kuiry (vide Jhalda PS CC No-1833/22 and Jhalda PS GDE No-438 dated-10/07/22) and as per order myself along with force were performing surprise NAKA checking duty at Dakagara under Jhalda PS (Jharkhand-Bengal border). At about 17:45 hrs we detained One Black & Green colour TVS sport motor cycle having registration no-JH09H9266 Chassis No-MD625MF54D1A72075, Engine No-CF5AD1827792 and the rider of the said motor cycle tried to flee away but after hot chase we apprehended him and on search found one Iron made improvised 7.65 mm pistol and Two round live 7.65 mm. ammunition which were loaded in the magazine of the pistol were recovered from his exclusive possession and unloaded the same safely and on being asked he failed to produce any papers in support of possessing or keeping the said fire arms and he also disclosed his identity as Salim Ansary (41 yrs) S/O Lt. Gul Mohammad Ansary of Vill-Bandulohar, PO-Mahatomara, PS-Jhalda, Dist- Purulia. On being asked he also stated that he brought the fire arms from Bokaro side and sale the same to the deferent persons of Jharkhand & Bengal in lieu of money. Accordingly I seized the above noted articles from his exclusive possession in-between 18:15 hrs & 18:50 hrs under proper seizure list and being labeled properly. During seizure & label I searched for the local disinterested persons to put sign on the Seizure List as well as Label, but no public witness could be made available. After seizure I arrested him at 18:55 hrs after observing all the legal formalities regarding arrest as his offence comes under the purview of Indian Arms Act.

Hence, I pray that a specific case may kindly be started against him under proper section of law and arrange for its investigation.
