In producing here with one arrested accused person namely Sanjay Karmakar (50) S/O Lt. Nirodbaran Karmakar of School More (Mosina), PS-Jhalda, Dist-Purulia under proper seizure of 87 (Eighty Seven) Pcs. sealed bottles of "ONEREEX" cough syrup of 100 ml each @ 154.50/- each, after preparing proper seizure list duly signed by the witnesses.

l, SI, Asoke Kr. Sen of Jhalda PS do here by lodged a written complain against Sanjay Karmakar (50) S/O Lt. Nirodbaran Karmakar of School More (Mosina), PS-Jhalda, Dist-Purulia to the effect that today (12/07/2022) while myself along with force (i) C/1207 Tarit Kr. Majhi (ii) C/1284 Pratapaditya Majhi (iii) HG/1807 Shyam Sing Laya & (iv) HG/1772 Fatik Ch. Kumar of Jhalda P.S. were performing evening mobile duty and at 19:15 hrs. received an information from SI Prasanta Sau, Duty officer of Jhalda PS (This refers to Jhalda P.S. GDE No- 536 Dt- 12/07/2022) that a huge quantity of cough syrup are stored in the Biswakarma Led & Welding Shop at Anandabazar, Ward No-2 under Jhalda P.S of Sanjay Karmakar. Accordingly, myself along with force left for Biswakarma Led & Welding Shop of Sanjay Karmakar to workout the information. We reached near Biswakarma Led & Welding Shop at 19:35 hrs. and parked the Govt. vehicle in a safe distance and conducted raid at the shop of Sanjay Karmakar. Myself along with force searched the shop thoroughly and found a huge quantity of cough syrup inside his shop. I asked him to produce any valid license in respect of keeping said illegal drugs. But he failed to produce any valid documents in respect of said drugs. So, I seized 87 (Eighty Seven) pieces sealed bottles of "ONEREEX" cough syrup of 100 ml each @ 154.50/- each, from the possession of Sanjay Karmakar in between 19:45 hrs. to 20:05 hrs. after preparing proper seizure list duly signed by Police witnesses due to unavailability of Public witnesses and label it.. On interrogation, Sanjay Karmakar confessed his guilt and admitted that he gathered the illegal cough syrup for the purpose of sale. So, I arrested Sanjay Karmakar (50) S/O Lt. Nirodbaran Karmakar of School More (Mosina), PS-Jhalda, Dist-Purulia for violation of Sec-27 of Drugs & Cosmetics Act-1940 and after maintaining all the formalities regarding arrest and all the guide line of Hon'ble Supreme Court and NHRC.

I, therefore pray before you to start a specific case against accused person namely Sanjay Karmakar (50) S/O Lt. Nirodbaran Karmakar of School More (Mosina), PS-Jhalda, Dist-Purulia as per law and arrange for its investigation.
