


Sub: F.I.R. against persons unauthorisedly occupied Government Vested Land

Apropos above, this is to inform him that as per enquiry of this office by the concerned R.I. on the basis of the application submitted by SK Rahim and five others it has been found that SK Kalim S/O - Chhutu of Village- Kantadih, PO - Jhalda Dist - Purulia, Pin - 723202 (W.B.) and Rakim Kazi S/O Idrish of village- Hussaindih, PO - Jhalda, Dist - Purulia, Pin- 723202 (W.B.) have constructed building in 3626 plot and trying to occupy plot no 3628 which are government vested land as per our present LR record of mouza - Jhalda, J.L. No. 131. They could not produce any legal document at the time of enquiry. Subsequently they are called for hearing on dated 28-06-2022 and 07-07-2022 in which the offenders are absent on the time of hearing.




