In producing herewith one arrested accd namely Baidyanath @ Gayaram Mahato (62 yrs) S/O Lt. Kalicharan Mahato of Vill-Baroganta (Tola Tentultar), PS-Jhalda, Dist-Purulia and seized articles viz. i) one local made improvised Iron pipe gun which is length approx 23 cm. breath approx 13 cm. and wooden butt which is length 8 cm. and breath approx 3 cm. with one live cartridge 8 mm which is back side written by 8 mm and K-5 under proper seizure list. I, S.I Prasanta Sau beg to inform you that today (14/07/22) during my evening mobile duty with force namely (i) C/1496-Subal Ch. Mahato, (ii) C/1284 Pratapaditya Majhi, (iii) NVF/1036 Parmatha Kuiry (iv) HG/1681 Manmatha Kumar (vide Jhalda PS CC No-1873/22 and Jhalda PS GDE No-618 dated-14/07/22) received an information at 18:15 hrs from you over mobile phone that one person namely Baidyanath @ Gayaram Mahato (62 yrs) S/O Lt. Kalicharan Mahato of Vill-Baroganta (Tola Tentultar), PS-Jhalda, Dist-Purulia was moving with a pipe gun at Baroganta village . Accordingly I along with force left for Vill-Baroganta (Tola Tentultar) to work out the information. At 19:05 hrs myself along with force arrived at Baroganta village and seeing the Police party said Baidyanath @ Gayaram Mahato tried to flee away and after hot chase we apprehended him and on search found one local made improvised Iron pipe gun which is length approx 23 cm. breath approx 13 cm. and wooden butt which is length 8 cm. and breath approx 3 cm. with one live cartridge 8 mm which is back side written by 8 mm and K-5. On being asked he failed to produce any papers in support of possessing or keeping the said fire arms and he also disclosed his identity as Baidyanath @ Gayaram Mahato (62 yrs) S/O Lt. Kalicharan Mahato of Vill-Baroganta (Tola Tentultar), PS-Jhalda, Dist- Purulia. Accordingly I seized the above noted articles from his exclusive possession in-between 19:15 hrs &19:55 hrs under proper seizure list and being labeled properly. During seizure & label I searched for the local disinterested persons to put sign on the Seizure List as well as Label, but no public witness could be made available. After seizure I arrested him at 20:05 hrs after observing all the legal formalities regarding arrest as his offence comes under the purview of Indian Arms Act.

Hence, I pray that a specific case may kindly be started against him Under Section 25 (1) (a) Arms Act and arrange for its investigation.
