Sir,

I, ASI Sisir Kr. Gope along with force return to PS and brought under seizure (i) 01 (one) Pick up van having registration No- WB55/4821 with damaged condition, (ii) DJ sound box 06 (six) pcs (measure of 04 sound box -length approx 4ft & width approx 1ft 8 inch, 02 box -length approx 2ft 3 inch & width approx 1 ft 8 inch) , (iii) Machine 3 pes, (iv) Stabilizer 1 pc, (v) Micro machine 1 pc, (vi) Charger 2 pes. (vii) Processor machine 01 pc. & (viii) Generator 01 pc. The fact in brief is that today (15.07.2022) Myself along with force namely i) RM-1498 Sachin Sewa ii) RM-1504 Sachin Chettri were performing day mobile duty in PS area vide Jhalda P.S. GDE No- 652 Dated- 15/07/2022 in consonance with Jhalda PS CC No- 1875/22 Dated- 15/07/2022. During my day mobile duty I received information at 08:05 hrs from an unknown caller that one Pick up van was capsized beside Jhalda Bagmundi pitch road at Palash jungle near Kutidih village. Then & there myself along with force went to the spot at 08:15 hrs and found that one pick up van bearing no WB55/4821 capsized beside the pitch road loaded with the above noted seized articles. I also held local enquiry and came to learn that on today (15/07/22) at about 07:55 hrs the aforesaid Pick up van was returning from Pundag under Joypur PS, Dist-Purulia towards Putidih village under Jhalda PS after attending marriage ceremony. The driver of the Pick up van also carried some people in the said vehicle. The driver of the Pick up van was driving the vehicle very dangerously. As a result the vehicle dashed a Palash tree and capsized beside the road and 09 (nine) people/persons received injury on their persons. Local people shifted the injured persons for treatment at Jhalda BPHC. The incident was occurred due to rash & negligent driving of the driver of the above noted vehicle. The driver of the pick up van fled away after leaving his vehicle. So I, seized the vehicle (i) 01 (one) Pick up van having registration No- WB55/4821 with damaged condition, (ii) DJ sound box 06 (six) pcs (measure of 04 sound box -length approx 4ft & width approx 1ft 8 inch, 02 box -length approx 2ft 3 inch & width approx 1 ft 8 inch) , (iii) Machine 3 pes, (iv) Stabilizer 1 pc, (v) Micro machine 1 pc, (vi) Charger 2 pes. (vii) Processor machine & (viii) 01 (one) pc generator under proper seizure list in presence of available witnesses duly signed by them. Thereafter, I brought the said Pick up van along with others seized articles to Jhalda PS compound.

I therefore pray that a specific Case may kindly be started against the driver of the Pick up van U/S- 279/337/338/427 IPC & 34A Police Act., WB. Amendment Act. 1963 and arrange for its investigation.
