Sir,

In producing here with 01(One) arrested accused person namely Laumash Ch. Mahato (42) S/O Rajani Kanti Mahato of Vill- Kudlong, PO- Torang, PS- Jhalda, Dist- Purulia and along with seized 01(one) Dumper having registration no- JH01DV0724 loaded with sand approx 500 cft . The fact in brief is that on (25/26.07.2022) I along with force namely (i) C/1284 Pratap Aditya Majhi (ii) C/240 Manoranjan Bagdi, (iii) NVF/1036 Parmatha Kuiry, (iv) HG/1681 Manmotha Kumar was performing night mobile duty in PS area vide Jhalda P.S. GDE No- 1173 Dated- 25/07/2022 in consonance with Jhalda PS CC No- 1982/22 Dated- 25/07/2022. During my night mobile duty I received credible source information that one dumper was lifting & carrying sand illegally and coming from Marcha ghat under Bagmundi PS towards Jhalda Town. Subsequently, I informed you and as per your gracious order, I placed Naka at Birshamore to work out this tip off and started Naka Checking after proper placing guard rail on the road. Thereafter I saw the one dumper was proceeding towards Jhalda Town. Consequently, we intercepted the said dumper at before Naka checking point at about 07:45 hrs and found that the vehicle as well as goods as identical as I received prior information. But seeing the Police Party driver who was on that vehicle (Dumper) started to flee away. After hot chase we managed to apprehend him. . On being asked, the driver of the vehicle disclose his name noted in the supra. I asked the driver of the vehicle to produce the valid documents in respect of the vehicle as well as the loaded sand. But the driver of the said vehicle could not able to produce any kind of documents in respect of the Dumper and the sand. I repeatedly asked the driver to produce the valid papers but he stated differently in different times. The incoherent statement of the driver purported to be a suspicious to us. It was ascertained that the driver of the dumper loaded the said sand in cahoots with the owner of the vehicle by illegal means for selling the same to make profit by dishonestly and they had been running a clandestine business. So it is reasoned to belief that he in cahoots with the owner of the vehicle procured the said sand from Subarnarekha River from Marcha Ghat by fraudulently means or theft by any means for transporting the same to run clandestine business. Ergo I, seized the dumper having registration No- JH01DV0724 with loaded sand (Approx 500 cft) under proper seizure list in presence of available witnesses duly signed by them and also arrested the driver namely Laumash Ch. Mahato (42) S/O Rajani Kanti Mahato of Vill- Kudlong, PO- Torang, PS- Jhalda, Dist- Purulia after informing the ground of arrest and issued Memo of Arrest against him. Thereafter, I brought the said dumper to Jhalda PS compound.

Under the above facts and circumstances kindly take lawful action against the driver namely Laumash Ch. Mahato (42) S/O Rajani Kanti Mahato of Vill- Kudlong, PO- Torang, PS- Jhalda, Dist- Purulia and the Owner of the said vehicle as they committed an offence U/S 379/411/413/414/120B of the IPC & 21 (4) Mines and Minerals (R&D) Act-1957.
