Sub: Prayer for starting a specific case against one Biswajit Mahato (24 yrs) S/o-Chinibas Mahato of Vill-Beltard PS-Joypur, Dist-Purulia (Motor Cycle Rider having Regd. No-JH09M-1039, Hero Honda Splendor +).

Respected Sir,

With due respect I Dhritiman Rakshit, beg to submit before you that on 17/07/2022 at about 20:15 hrs while myself along with C/-894 Dhananjoy Mandal & C/-516 Chandra Shekhar Mahato were performing Evening Mobile against drunken driving and rash driving duty vide Joypur PS CC No-2866/22 Dated-17/07/2022 at Dumurdih More on Purulia-Ranchi Road (SH-4A). I found one Motor Cycle was coming from Jhalda side towards Purulia **driving dangerously**. Police personnel of Naka party in proper Police uniform raised hand and directed him to stop the Motor Cycle but said Motor Cycle rider violating the Police Signal and endangering the human life rush and negligently driving the Motor Cycle which may cause any time accident to the road user. We can able to apprehend him at Dumurdih more. With tested him through breath analyzer and he was detected with Alcohol vide Serial No-93000493 & Record No-00046. On interrogation he made incoherent statement at different time. He disclosed his identity as Biswajit Mahato (24 yrs) S/o-Chinibas Mahato of Vill-Beltard PS-Joypur, Dist-Purulia. On being asked he failed to produce any other valid documents of Motor Cycle. Hence he violated the provision of Section 279 IPC & R/W Section-184/185 MV Act. So I seized the Motor Cycle having Regd. No-JH09M-1039, Hero Honda Splendor +, at 21:15 hrs to 21:35 hrs under proper seizure list duly signed by the witnesses and arrested the offending rider namely Biswajit Mahato (24 yrs) S/o-Chinibas Mahato of Vill-Beltard PS-Joypur, Dist-Purulia at 21:40 hrs after observing all formalities and explained the ground of arrest, issued memo of arrest. As the offence is bailble hence accused rider namely Biswajit Mahato was released on bail.

So I pray specific case may kindly be registered against the accused namely Biswajit Mahato (24 yrs) S/o-Chinibas Mahato of Vill-Beltard PS-Joypur, Dist-Purulia (Motor Cycle Rider having Regd. No-JH09M-1039, Hero Honda Splendor +) for committing offence U/S-279 IPC & R/W Section-184/185 MV. Act.
