I do hereby lodge complaint empowered by enabling the electricity act 2003 subsequently the amendment act 2007 to the effect that Fagual Mahato, S/O-Hiralal Mahato of village-Madhupur(Near Deulghata Jal Tank), P.O-Tunta P.S- Joypur, Dist- Purulia has committed theft of electricity U/S 135(1) (a) of electricity act 2003 subsequently amendment act 2007.

On 20.07.2022 at about 05.40 P.M. I Sri Raushan Kumar, JE(E) Grade-II, Station Manager, Joypur CCC along with 01.Ganesh Mahato, Gr1 TSH, Joypur CCC, 02.Haragobinda Singh Mura, Sr. OE, Joypur CCC entered the premises of Fagual Mahato, S/O-Hiralal Mahato of village-Madhupur(Near Deulghata Jal Tank), P.O-Tunta P.S- Joypur, Dist- Purulia and found that Fagual Mahato, S/O-Hiralal Mahato was enjoying electricity unauthorizedly drawing power from the LTOH line of WBSEDCL through PVC cable yellow and Black colour 1.5 Sqmm aluminum wire with hooking arrangement by means direct hooking to his commercial(Hotel) premises and connected load found 0.1 KW. As that Fagual Mahato, S/O-Hiralal Mahato committed theft of electric power. So, I seized the following articles after preparing the seizer list in presence of 01.Ganesh Mahato, Gr1 TSH, Joypur CCC, 02.Haragobinda Singh Mura, Sr. OE, Joypur CCC. The inspection team left the premises at 6.15 P.M.

Sized Articles

01. PVC Cable yellow and black clour 1.5 Sqmm aluminum wire = 10.05 Meter (approx) each, total = 21 mtr (approx).

Fagual Mahato, S/O-Hiralal Mahato of village-Madhupur(Near Deulghata Jal Tank), P.O-Tunta P.S- Joypur, Dist- Purulia has committed an offence U/S 135(i) (a) Electricity Act, 2003(Amendment Act, 2007), so you are requested to take cognizance of this complaint and treat it as F.I.R.
