Sir,

In producing herewith 01 (one) seized Mini Truck (407) bearing Regd. No. WB37-9199 loaded with approx 07 MT coal as per seizure list and submitting a written complaint against the driver and owner of the Mini Truck (407) bearing Regd. No- WB37-9199, to the effect that today i.e. 23/07/2022 myself along with C/-2620 Jayanta Kapat, NVF/-817 Bhubaneswar Mahato both of Joypur PS were performing Special Mobile-II duty at PS area vide CC No-2934/22 Dated-23/07/2022. During mobile duty at about 21:15 hrs received a credible source information that one Mini Truck (407), loaded with coal was coming from Adrakuri side towards Gunja More. After receiving source information, I informed the matter to IC Joypur PS and as per your kind direction we proceeded to work out the information. When we reached near Gunja more I found 01 (one) Mini Truck (407) was coming towards Gunja More. We able to detained the truck near Gunja village. We stopped the said Mini Truck but seeing police, the driver of the mini truck fled away. We tried to detain him but we failed. During search, it is found that the said Mini Truck having Registration No-WB37-9199 was loaded with approx 07 MT coal. So, it is reasonable to believe that the driver and the owner of the said Mini Truck collected the said coal either by theft or by any other fraudulent means from anywhere and transporting the same to run clandestine business for wrongful gains. As such, there is every reason to believe that the driver and the owner of the said Mini Truck transporting coal illegally. So I seized one Mini Truck (407) having registration No. WB37-9199 loaded with approx 07 MT suspected to be stolen coal under proper seizure list duly signed by witnesses. No public witness was available there. Approx 01 (One) K.G. of Coal sealed & labeled as sample coal from major contraband.

I therefore pray before you, kindly lodge an FIR against the driver and owner of the Mini Truck (407) bearing Regd. No- WB37-9199 as per law and arrange for its investigation.
