Sub: Prayer for lodging FIR against accd. Naran Gorain (50y), s/o Lt Kali Gorain of Vili-Karkara, PS-Joypur, Dist-Purulia, U/S 46A (c) B.E. Act 1909.

Sir.

In producing herewith arrested accused Naran Gorain (50y), s/o Lt Kali Gorain of Vili- Karkara, PS-Joypur Dist-Purulia along with seizure – list and seized items as described below, I beg to state that on 28.07.220 at about 17.05 hrs received a source information to the effect that the country spirit has been kept at Karkara village into the shop of above noted accused, illegally with an object to sale. I convey the matter to the OC Baglata Investigation Center and as per order of OC Baglata IC. I along with force left for Karkara vilage to work out the information with the Govt. supplied kits box containing white cloth, sealing wax, seal, papers, carbons, match box, candles etc.(this refers Baglata IC GDE No- 849, dated 28.07.22).

I had been to the Shop of Naran Gorain at Karkara village, P.S. Joypur at about 18:35 hours. Seeing police van some unknown persons in front of the shop of Naran Gorain fled away. However, I could detain 01 (one) among them and asked about his identity, he disclosed his name and identify as above and as well as informed that, he gather the country spirit (Dilkhush) for selling and he was the owner of the said shop. However, I along with said accused started a search inside the shop of Naran and found the following item in the said house.

1) 20 (Twenty) bottles 80UP country spirit (Dil Se) each bottles containing 600 ML market value of each being in total approx Rs. 1,100/- (One Thousand only) 01 (One) bottle of 600 ML taken (Dil Se) out of the above as sample packet, labeled and sealed with sealing wax.

Sale Proceed cash of Rs.- 110/- (One hundred ten only)

I interrogated him about the purpose of the stocking and possessing country spirit, Naran Gorain replied it was the business of him of this said country sprit. On repeated question he told that the persons who fled away were his customers (names of those not known to him). However he could not show any documents/papers in support of the possession as well as sale of the said articles.

As such, I seized the above items as ALAMAT under proper Seizure List between 19:05 hrs and 19.25 hrs & took up one bottle of each brand as samples, labeled and sealed accordingly.

Since the allegation against him of possessing, as well as selling the country spirit illegally without any valid papers in his house has prima-facie been made out and for the interest of proper investigation. I arrested the above accused at 19.30 hrs accordingly.

Therefore, I pray before you to start a case under proper section of law against the said accused Naran Gorain (50y), s/o Lt Kali Gorain of Vili- Karkara, PS-Joypur, Dist-Purulia.
