Sub: Prayer for starting a specific case against one Santosh Mahato (25 Yrs) S/O- Nimai Chandra Mahato of Vill-Hesalbera PO-Durg PS-Jhalda, Dist-Purulia (Motor Cycle Rider having Regd. No-JH01AX-0963 Splender+).

Respected Sir,

With due respect I SI Dibakar Kuiri, beg to submit before you that on 04/07/2022 at about 18:30 hrs while myself along with C/-2672 Pradip Patra, C/-JC/-1489 Amit Saw were performing Special drive against drunken driving and rash driving duty vide Joypur PS CC No-2007/22 Dated-04/07/2022 at Dumurdih More on Purulia-Ranchi Road (SH-4A). I found one Motor Cycle was coming from Purulia side towards Jhalda with **Excessive Speed & Driving Dangerously**. Police personnel of Naka party in proper Police uniform raised hand and directed him to stop the Motor Cycle but said Motor Cycle rider violating the Police Signal and endangering the human life rush and negligently driving the Motor Cycle which may cause any time accident to the road user. After long chase we can able to apprehend him at Dumurdih more. On interrogation he made incoherent statement at different time. He disclosed his identity as Santosh Mahato (25 Yrs) S/O- Nimai Chandra Mahato of Vill-Hesalbera PO-Durg PS-Jhalda, Dist-Purulia. On being asked he failed to produce any other valid documents of Motor Cycle. Hence he violated the provision of Section 279 IPC & R/W Section-183(1)/184 MV Act. So I seized the Motor Cycle having Regd. No- JH01AX-0963 Splender+ at 20:25 hrs to 20:35 hrs under proper seizure list duly signed by the witnesses and arrested the offending rider namely Santosh Mahato (25 Yrs) S/O- Nimai Chandra Mahato of Vill-Hesalbera PO-Durg PS-Jhalda, Dist-Purulia at 20:40 hrs after observing all formalities and explained the ground of arrest, issued memo of arrest. As the offence is bailble hence accused rider namely Santosh Mahato was released on bail.

So I pray specific case may kindly be registered against the accused namely Santosh Mahato (25 Yrs) S/O- Nimai Chandra Mahato of Vill-Hesalbera PO-Durg PS-Jhalda, Dist-Purulia (Motor Cycle Rider having Regd. No-JH01AX-0963 Splender+).for committing offence U/S-279 IPC & R/W Section-183(1)/184MV. Act.
