
Sir,  
In producing herewith, (1) Red colour Mahindra B 275 DI, Bhumiputra having Registration No WB55B/5671 along with trolley (Without number plate) loaded with approx 60-70 CFT sand (2) One piece of iron made "Belcha" having wooden butt (3) One piece of iron made "Dhama"

The nub of the fact in a nutshell is that today on 03.07.2022 at 07.45 hrs. I ASI Shibram Bauri of Kashipur PS along with (i) C/628 Giridhari Bauri and (ii) C/1191 Subodh Hansda both of Kashipur PS, Dist - Purulia, left the PS for performing mobile duty at Kashipur P.S area vide Kashipur P.S GDE No. 91 Dtd - 03.07.2022 and C.C No. 1829/22 Dtd. 03.07.2022. During my mobile duty, I received a tip off at 13.35 hrs. that some persons were loading a tractor with sand from the river bed of Darkeswar River near Chapri village under Kashipur P.S. Subsequently, I along with force moved to the spot. We kept the vehicle on the bank of river and proceeded towards the spot by foot. We came to find that few persons were loading sand in the attached trolley of said tractor. Seeing the Police party, those persons leaving the tractor (loaded with sand in the attached trolley) at Darkeswar River and fled away from the spot. We rushed to the tractor and detained the said tractor. We searched the said tractor and found that the tractor is loaded with sand and also searched surrounding but could not trace out the persons & driver of said offending tractor. I searched the vehicle if any valid documents is available regarding said loaded sand but found nothing. Hence, I seized the above noted tractor along with trolley loaded with sand as noted above and brought the said seized articles to Kashipur PS. As there is every reason to believe that the driver and owner of the said tractor with ill motive were transporting sand illegally without any valid document in support of carrying sand.

Hence, I do hereby lodge this complaint against the owner and driver of above noted tractor along with the trolley for investigation.
