In producing herewith the following seized articles i.e. 1) One Red colour Mahindra Bhoomiputra 265 D1 Tractor having Engine No- NGNL264 along with Trolly(Without Regd. No) and loaded with appx 70-75 cft of stone 2) One Yellow JCB Machine having Rgd No- WB 81/0986.

1 PS1 Gouranga Roy of Kashipur PS do here by lodge a complaint to effect that today on 05/07/22 I along with C/1256 Anadi Dhibar and C/2280 Akinchan Mandal was engaged in PS area mobile duty vide Kashipur PS CC No- 1859/22 dtd- 05.07.22. In course of mobile duty at 16.45 hrs received reliable source information to the effect that illegal extraction work of stone is going on near Chitaraghunathpur village with the help of JCB Machine. Informed the matter to O/C Kashipur PS and as per his direction left for Chitaraghunathpur area to work out the information.

At about 17:05 hrs we reached near Chitaraghunathpur Village and started searching the area on foot by keeping our vehicle at a far distance for looking any activity of illegal mining and extraction of stone as the said area is known for illegal mining of stone. We proceeded towards Tipirdih Dungri and found some persons were engaged in extracting and mining stone by digging the earth by using JCB Machine and loading on a Tractor. On seeing us and getting the scent of police party the driver of the Tractor and JCB Machine and the labours fled away from the spot. We searched the said tractor and found that the tractor is loaded with stone appx- 70-75 cft and the JCB machine which is used for extracting of stone from the said land. Searched the surrounding but could not trace out the persons & driver of said offending tractor as well as of the JCB machine. I searched both the vehicle if any valid documents is available regarding said loaded stone or about the particulars of the vehicles but found nothing. Hence, I seized the Red colour Mahindra Bhoomiputra 265 DI Tractor having Engine No- NGNL264 along with Trolly(Without Regd. No) and loaded with appx 70-75 cft of stone 2) One Yellow JCb Machine having Rgd No- WB 81/0986 under proper seizure list and brought the said seized articles to Kashipur PS. As there is every reason to believe that the driver and owner of the said tractor and driver and owner of the JCB Machine with ill motive were engaged in extracting and transporting stone illegally without any valid document in support of carrying and digging.

Hence, I do hereby lodge this complaint against the owner and driver of above noted tractor along with the trolley loaded with stone and driver and owner of the JCB machine for starting a case against them under proper section of law.
