In producing herewith the arrested accused persons namely Shaktipada Das (48 Yrs) S/o- Kalachand Das of village- Mahulbana, PS-Bandwan , Dist- Purulia along with one seized Geny Grey Metallic colour Honda dream Neo 110 Motor Cycle bearing Reg. No- WB56M-1520 having Engine No- JC78E80008634, Chassis No- ME4JC781FH.

I beg to report that today myself along with C/1177 Samir Das and C /2644 Mithun Duley both of Kenda PS were performing Naka Checking duty at Jamtal Morh under Kenda PS area vide Kenda PS C.C No-764/22 dtd. 15.07.2022 and Kenda PS GDE No-465 dtd- 15.07.22 as per your kind order. At about 17:05 hrs, I found one motor Cycle Geny Grey Metallic colour Honda dream Neo 110 coming from Kenda village side rashly and negligently. Myself along with force tried to stop them but the driver of the said motorcycle was trying to escape the place rashly. There was every possibility of loss of life / serious injury of nearby public. After a hot chase we could able to stop him. On being asked, he stated his name and address as noted above, As such seized Motor Cycle bearing Reg.No- WB56M-1520 having Engine No- JC78E80008634, Chassis No- ME4JC781FH in presence of witnesses. There after arrest the accused person after issued memo of arrest as he violated Sec. 279 IPC. I informed them about his ground of arrest and being informed his family members accordingly.

Therefore, I pray that a specific case may kindly be start against accused person namely Shaktipada Das (48 Yrs) S/o- Kalachand Das of village- Mahulbana, PS-Bandwan , Dist- Purulia.
