In producing herewith the arrested accused persons Ashok Mahato (28 Yrs) S/o- Shankar Mahato of village- Swarupdih, PS-Manbazar, Dist- Purulia along with one black red colour Honda CB Shine Disk Motor Cycle bearing Reg. No- WB56 F-4639

I beg to report that today myself along with C/ 315 Mir Kurban and NVF- 129 Mahanta Murmu both of Kenda PS were performing Naka Checking duty at Jamtal Morh under Kenda PS area vide Kenda PS C.C No-785/22 dtd. 20.07.2022 and Kenda PS GDE No-621 dtd- 20.07.22 as per your kind order. At about 17:05 hrs, I found one motor Cycle black red colour Honda CB Shine Disk coming from Kenda village side rashly and negligently. Myself along with force tried to stop them but the driver of the said motorcycle was trying to escape the place rashly. There was every possibility of loss of life / serious injury of nearby public. After a hot chase we could able to stop him. On being asked, he stated his name and address as noted above, As such seized Motor Cycle bearing Reg. No- WB56 F-4639 in presence of witnesses. There after arrest the accused person after issued memo of arrest as he violated Sec. 279 IPC. I informed him about his ground of arrest and being informed his family members accordingly.

Therefore, I pray that a specific case may kindly be start against accused person namely Ashok Mahato (28 Yrs) S/o- Shankar Mahato of village- Swarupdih, PS-Manbazar, Dist- Purulia
