Sir,

I, SI Joydev Mahato of Kenda PS, Dist- Purulia producing herewith one arrested accused person namely Bharat Kishor Mahato (45 yrs), S/o-Lt. Manohar Mahato of Vill-Bharatdih, P.S – Kenda, Dist- Purulia with seized articles i.e. 1) one white colour jarican containing approx 09Ltrs. ID Liquor 2) 05 pcs plastic glasses (3) Approx 375 ml ID liquor as sample which was collected from seized articles from Sl. No-01 & kept in a bottle which were seized under proper seizure list.

I beg to submit that today (23-07-2022) during evening Mobile duty acting of a secret source information myself along with C/2644 Mithun Duley, NVF- 159 Dhiren Hansda HG-1923 Banamali Manki all are of Kenda PS conducted raid in the house of accused person Bharat Kishor Mahato at about 17.05 hrs and found that he was keeping and selling of ID liquor at his house to the others. Seeing the Police party, all customers fled way but we managed to apprehended the above noted accused person. On being asked he failed to produce any valid licence /documents in respect of storing and selling of ID liquor. As such I seized 1) one white colour jarican containing approx 09 Ltrs. ID Liquor 2) 08 pcs plastic glasses (3) Approx 375 ml ID liquor as sample which was collected from seized articles from Sl No-01 & kept in a bottle which were seized under proper seizure list in presence of witnesses and duly signed by them and also arrested the above noted accused person after informing him the ground of arrest and after observing all legal formalities. The seized articles were properly sealed and labelled in presence of witnesses. I also arranged to inform his family member about his arrest by police.

Under the above fact and circumstances, I therefore pray that a specific case may kindly be start against Bharat Kishor Mahato (45 yrs), S/o-Lt. Manohar Mahato of Vill-Bharatdih, P.S – Kenda, Dist- Purulia under proper section of law.
