Sir,

I, SI Joydev Mahato of Kenda PS, Dist- Purulia producing herewith two arrested accused persons namely (i) Manbhula Sahis (58 yrs), S/o-Lt. Rashan Sahis (ii) Lafar Sahis (52 yrs), S/o- Lt. Khandu Sahis both of Vill- Damda, P.S – Kenda, Dist- Purulia with seized articles i.e. 1) one white colour jarican containing approx 14 Ltrs. ID Liquor 2) 08 pcs plastic glasses (3) Approx 375 ml ID liquor as sample which was collected from seized articles from Sl. No-01 & kept in a bottle which were seized under proper seizure list.

I beg to submit that today (28-07-2022) during evening Mobile duty acting of a secret source information myself along with C/1137 Sidam Bauri, C- 2519 Anan Duley both of Kenda PS conducted raid in Damda village ground at about 19.05 hrs and found that they are keeping and selling of ID liquor at Damda village ground. Seeing the Police party, all customers fled away but we managed to apprehended the above noted accused persons. On being asked they failed to produce any valid licence /documents in respect of storing and selling of ID liquor. As such I seized 1) one white colour jarican containing approx 14 Ltrs. ID Liquor 2) 08 pcs plastic glasses (3) Approx 375 ml ID liquor as sample which was collected from seized articles from Sl No-01 & kept in a bottle which were seized under proper seizure list in presence of witnesses and duly signed by them and also arrested the above noted accused persons after informing them the ground of arrest and after observing all legal formalities. The seized articles were properly sealed and labelled in presence of witnesses. I also arranged to inform his family member about his arrest by police.

Under the above fact and circumstances, I therefore pray that a specific case may kindly be start against (i) Manbhula Sahis (45 yrs), S/o-Lt. Rashan Sahis (ii) Lafar Sahis (45 yrs), S/o- Lt. Khandu Sahis both of Vill- Damda, P.S – Kenda, Dist- Purulia under proper section of law.
