In producing herewith the arrested accused persons namely Srinath Tudu (25 Yrs) S/o- Bishbeshbar Tudu ii) Suchand Hembram (40) S/o- Raju Hembram both of village- Banbandha, PS- Balarampur , Dist- Purulia iii) Sumanta Murmu (23) S/o- Lalmohan Murmu of village- Tuima, PS- Barabazar , Dist- Purulia along with one seized Blue colour TVS Appachi RTR 2VFD BS-6 Motor Cycle bearing Engine No- AE8LM2829344, Chassis No- MD6304AE82M2L30098

I beg to report that today myself along with C/631 Tulshi Das Satpathi and C /1137 Sridam Bauri both of Kenda PS were performing Naka Checking duty at Jamtal Morh under Kenda PS area vide Kenda PS C.C No-738/22 dtd. 09.07.2022 and Kenda PS GDE No-255 dtd- 09.07.21 as per your kind order. At about 13:45 hrs, I found one blue coloured motor Cycle riding with 03 (Three) persons were coming from Darodih Morh side along Purulia - Manbazar road (SH-05) with rashl and negligent manner. Myself along with force tryed to stop them but the driver of the said motorcycle was trying to escape the place rashly. There was every possibility of loss of life / serious injury of nearby public. After a hot chase we could able to stop them., But the driver of the said motorcycle and his another 02 (Two) pillion riders unable to give any satisfactory account for their such rush and negligent driving. which may cause endanger to human life. On being asked, they stated their name and address as noted above .As such seized Motor Cycle bearing Engine No- AE8LM2829344, Chassis No- MD6304AE82M2L30098 in presence of witnesses. There after arrest the accused persons after issued memo of arrest as they violated Sec. 279 IPC & 128/194(C) MV Act. I informed them about their ground of arrest and being informed their family members accordingly.

Therefore, I pray that a specific case may kindly be start against accused persons namely Srinath Tudu (25 Yrs) S/o- Bishbeshbar Tudu ii) Suchand Hembram (40) S/o- Raju Hembram both of village- Banbandha, PS- Balarampur , Dist- Purulia iii) Sumanta Murmu (23) S/o- Lalmohan Murmu of village- Tuima, PS- Barabazar , Dist- Purulia.
