

4.Occurrence:

On 23-03-2022 corresponding to 8th. Chaitra 1428 B.S. at about 4 P.M.

5.Offences:-

The above named complainant begs to state as follows .

1----That your petitioner is the permanent resident of village Barorola under Kotshila Police station. . The accused persons are known to the complainant who has enimical terms since long due to business matter. The accused persons threatened the complainant that they would see him and taught a good lesson when chances would be avail to them .

3----That on the date of occurrence at about 4.00 P.M., when the complainant was going to his sister's house at village Kanudih at that time the accused persons restrained him near Adardih Bridge and all on a sudden pushed him. The complainant fall down on the earth due to such sudden push by the accused persons. Thereafter the accused persons started to assault the complainant indiscriminately and dragged him on the river bed and assault him with stone on his chest and due to such heavy blow on the chest the complainant lost his sense and some time after he regained his sense. Then the accused persons dragged the complainant to the nearby Railway Track and kept him on the Rail Line and fled away. Some time after the nearby villagers noticed the complainant is lying unconscious on the Rail way Truck and brought him to Kotshila B.P.H.C.in injured condition for treatment and the doctor of Kotshila B.P.H.C. treated the complainant and seeing the critical condition of the injured immediately referred him to Purulia Govt, Medical College & Hospital for better treatment where he was admitted as indoor patient and treated there for some days.

4----That your petitioner informed the matter to Kotshila Police Station but the police is totally inactive and evasive in the matter reasons best known to them . There after your petitioner knocked the door of the Superintendant of Police Purulia on 16-04-2022, but nothing has been done from his good office hence this application .

5----That your petitioner is a very poor man having no source of income . He is not in a position to conduct the case in his own cost , More over there are some technical and legal aspect involved in this case which requires considerable money and machinery . So a police case is highly desirable

It is prayed that your honour may be graciously pleased to direct the O/C Kotshila Police Station to investigate the case in accordance with law treating the same as F.I.R. as contemplated U/S 156(3) Cr.P.C.
