Respected Sir,


With due respect I ASI Tushar Kanti Mandal, beg to submit before you that on 04/07/2022 at about 17:15 hrs while myself along with C/-970 Dolan Biswas, C/-633 Dasarath Sing Mura were performing Naka Checking duty vide Kotshila PS CC No. 1178/22 Dated-04/07/2022 at Jiudaru School More on Purulia-Ranchi Road (SH-4A). I found one Motor Cycle was coming from Purulia side towards Jhalda with **Drive dangerously**. Police personnel of Naka party in proper Police uniform raised hand and directed him to stop the Motor Cycle but said Motor Cycle rider violating the Police Signal and endangering the human life rush and negligently driving the Motor Cycle which may cause any time accident to the road user. After long chase we can able to apprehend him at Jiudaru School more. On interrogation he made incoherent statement at different time. He disclosed his identity as Trilochan Kumar (22 Yrs) S/O- Puran Kumar of Vill-Beradih, PS-Kotshila, Dist-Purulia. On being asked he failed to produce any other valid documents of Motor Cycle. Hence he violated the provision of Section 279 IPC & R/W Section-184/181 MV Act. So I seized the Motor Cycle having Regd. No. JH09AV-1011 Hero Splender+ at 17:25 hrs to 17:35 hrs under proper seizure list duly signed by the witnesses and arrested the offending rider namely Trilochan Kumar (22 Yrs) S/O- Puran Kumar of Vill-Beradih, PS-Kotshila, Dist-Purulia at 17:55 hrs after observing all formalities and explained the ground of arrest, issued memo of arrest. As the offence is bailable hence accused rider namely Trilochan Kumar was released on bail.

So I pray specific case may kindly be registered against the accused namely Trilochan Kumar (22 Yrs) S/O- Puran Kumar of Vill-Beradih, PS-Kotshila, Dist-Purulia (Motor Cycle Rider having Regd. No. JH09AV-1011 Splender+) for committing offence U/S-279 IPC & R/W Section-184/181 MV. Act..
