Sir,

In producing herewith 01(one) arrested accd. person namely Goutam Gope (23 yrs) S/o Genesh Gope of vill.- Briddhitntr, P.O-Thakursima, PS-Arsha, Dist.- Purulia along with seized one red colour tractor bearing registration no. WB55B/5349 (Chassis No. MBNSFAVBBMNC01100, Engine No. NMC5FAE0026) - model – Mahindra YUVO 415 DI attached with trolley loaded sand 100 CFT (approx) under proper seizure list, I beg to submit that today (12/07/2022) I along with (1) C/633 Dasarath Singh Mura (2) C/ 292 Kritibas Mahato both of Kotshila P.S were performing Special Mobile duty vide Kotshila PS Special CC No. 1255/22 Date 12.07.2022. During my special mobile duty at about 20.05 hrs I along with force reached near Begunkodar Bazar under Kotshila PS and found that one red colour tractor bearing registration no. WB55B/5349 named as 'Mahindra YUVO 415 DI' attached with trolley loaded with sand 100 CFT (approx) was coming from Bartalia side. On seeing the Police party near Begunkodar Bazar, the driver of the said tractor was trying to flee away. But after a hot chase, we could able to detain the driver of said tractor and on asking he disclosed his identity as Goutam Gope (23 yrs) S/o Genesh Gope of vill.- Briddhitntr, P.O-Thakursima, PS-Arsha, Dist.- Purulia . I asked the driver Goutam Gope to produce valid documents in respect of said sand but he failed to produce any documents regarding lifting & transportation of sand. During interrogation he confessed that he loaded the tractor with sand by illegal manner for selling the same to make profit by dishonestly for running clandestine business consent with the owner of the said tractor. So, I seized the tractor bearing registration no. WB55B/5349(Chassis No. MBNSFAVBBMNC01100, Engine No. NMC5FAE0026) - model – Mahindra YUVO 415 DI attached with trolley loaded with sand under proper seizure list from 20.25 hrs to 20.45 hrs duly signed by police witness and I arrested the driver namely Goutam Gope (23 yrs) S/o Genesh Gope of vill.- Briddhitntr, P.O-Thakursima, PS-Arsha, Dist.-Purulia at 20.55 hrs after issuing Arrest Memo and observe all legal formalities of arrest also informed him regarding ground of arrest. The said driver could not produced any driving license at the time of arrest. As such there is every reason to believe that the driver and owner of the tractor with ill motive are habitually dealing with sand illegally for selling the same to make profit by dishonestly for running a clandestine business without any valid document. So they are liable for offence punishable U/S 379/411/414/120B IPC & 21 (1) (4) Mines and Minerals (R&D) Act-1957.

Therefore, I pray before you that a case against the driver namely Goutam Gope (23 yrs) S/o Genesh Gope of vill.- Briddhitntr, P.O-Thakursima, PS-Arsha, Dist.- Purulia, and owner of the tractor bearing registration no. WB55B/5349 (Chassis No. MBNSFAVBBMNC01100, Engine No. NMC5FAE0026) - model – Mahindra YUVO 415 DI may kindly be started and arrange for its investigation.
