Sir,

In producing here with one arrested accused namely Nasir Ansary (66) s/o Lt Sahabali Ansary of vill.-Barametyala, PS-Kotshila, Dist-Purulia and seized articles i) one Iron made improvised 7.65 mm pistol loaded with one magazine in which length of the barrel approx 5.9 inches and length of butt approx 3.5 inches in which the firing pin is present and ii) two rounds live 7.65 mm ammunitions and those were loaded in magazine of sl no. 1 under proper seizure list duly signed by the witnesses, I SI Purnendu Datta of Kotshila PS beg to inform you that today (15.07.2022) during my evening Spl mobile duty with accompanied force namely C- 292 Krittibas Mahato & C- 1279 Bhabataran Mahato both of Kotshila PS vide Kotshila PS GDE No. 625 and Kotshila PS CC No.1286/22 Dated 15.07.2022) received an information at 20:15 hrs at Khatanga village side from Duty Officer ASI Pankaj Gupta that one person namely Nasir Ansary (66) s/o Lt Sahabali Ansary of vill.-Barametyala, PS-Kotshila, Dist-Purulia was moving with a fire arms at near Chitmu VIP more under Kotshila PS. ASI Pankaj Gupta diarised the matter in General Diary (vide Kotshila PS GDE No. 627 Date. 15.07.2022 and inform to O/C Kotshila PS and as per instruction of O/C Kotshila PS he informed me to work out the matter. Accordingly I along with force left for Chitmu VIP more under Kotshila PS to workout the information. At 21.05 hrs myself along with force arrived at Chitmu VIP more and seeing the police party said Nasir Ansary tried to flee away and after a hot chase we apprehended him. I asked him that why he tried to flee away. Then he made incoherent statement. I searched him on the spot and found one Iron made improvised 7.65 mm pistol loaded with one magazine in which length of the barrel approx 5.9 inches and length of butt approx 3.5 inches in which the firing pin in present and ii) two round live 7.65 mm ammunition and those were loaded in magazine which was kept in left side of the waist concealed under the shirt of Nasir Ansary. On demand he was unable to produce any valid documents/license in respect of keeping such arms & ammunitions, neither he can gave any satisfactory explanation in respect of carrying such arms ammunitions. It appeared he possessed those either to sell or to commit any crime. I unload the ammunition from the said improvised arms after taking all precaution and seized the said arms and ammunitions with proper seizure list also the seized arms and ammunitions packed, sealed and labeled in presence of police witnesses since none found there available to witness. The seizure was made in between 21.25 hrs and 21.55 hrs. Hence I arrested him at 22:05 hrs as he has committed an offence which is punishable U/S 25(1)(a) of The Arms Act 1959.

Hence I pray to start specific case against arrested accused person namely Nasir Ansary (66) s/o Lt Sahabali Ansary of vill.-Barametyala, PS-Kotshila, Dist-Purulia U/S 25(1)(a) of The Arms Act 1959.
