In producing here with 01(One) arrested accused person Biplab Paramanik (23) S/O-Ambuj Paramanik of Vill-Lachipur, P.O-Gopalpur, PS-Hirbandh, Dist-Bankura along with seized Motor Cycle (Pulsar, Blue colour) bearing Reg. No.WB68AG/8670 with all connected papers.

I beg to state that today i.e on 04.07.2022 in course of my mobile duty vide Manbazar PS GDE No.164 dt.04.07.2022 I had been to Baropol area at 20.05 hrs and 20.25 hrs found that the above noted person with his Motor Cycle bearing Reg. No.WB 68AG/8670 (Pulsar, Blue colour) was coming from Basudih side with excessive sped and rough driving in negligence manner without wearing protective head gear. Myself along with force signalled to stop him but the driver of the said Motor Cycle drove speedily and disobediently and tried to flee away. Somehow we could be able to detain him at Indkuri morh on Bankura-Manbazar road under Manbazar PS. This rough and negligence driving of driver would lead to an accident at any time. Any passerby could be injured by such activities. On being asked the above accd. Person could not be able to give any satisfactory answer for that movement on road and public place by such rough driving. So I arrested him at 20.45 hrs for rough and negligent driving and disobeying the order duly promulgated by public servant, after maintaining all rules of arrest, issued memo of arrest. So, a specific case may be initiated against Biplab Paramanik (23) S/O-Ambuj Paramanik of Vill-Lachipur, P.O-Gopalpur, PS-Hirbandh, Dist-Bankura as per law and arrange for its investigation.
