In producing here with 01 (One) arrested accused person Arjun Orang (22 yrs) S/O- Lt. Samar Orang of village- Toparbaid, PS- Boro, Dist- Purulia along with seized motor Cycle bearing Regn No. JH 05 T 3368 (Silver & Blue Colour Hero Honda Deluxe).

I beg to state that today i.e on 15.07.2022 in course of my mobile duty vide Manbazar PS GDE No- 629, dtd 15.07.2022 I had been to Chawkbazar morh area at 18:05 hrs and at 18:15 hrs found that the above noted person with his motorcycle bearing regn No JH 05 T 3368 (Silver & Blue Colour Hero Honda Deluxe) was coming from Indkuri morh side with excessive speed and rough driving in negligence manner without wearing protective head gear. Myself along with force signaled to stop him but the driver of the said Motorcycle drove speedily and disobediently and tried to flee away. Somehow we could be able to detain him at near Chawkbazar morh on Bandwan -Manbazar road under Manbazar PS. This rough and negligence driving of driver would lead to an accident at any time. Any passerby could be injured by such activities.
