

In producing here with 04 (04) arrested accused persons namely 1) Bhyam Chand Bauri S/O Madhu Bauri of village Madhupur PS- Manbazar, Dist- Purulia along with seized motor Cycle bearing Regn. No. JH02R/1689 (Red colour Yamaha) with all connected papers.

I beg to state that today i.e on 22.07.2022 in course of my mobile duty vide Manbazar PS GDE No- 936, dtd 22.07.2022 I had been to PDGM High School morh on Manbazar Bandwan Pitch Road at 19:35 hrs and at 20:05 hrs found that the above noted person with his motorcycle bearing Regn No. JH02R/1689 (Red colour Yamaha) was coming from Golkirdih morh side with excessive speed and rough driving in negligence manner without wearing protective head gear. Myself along with force signaled to stop him but the driver of the said Motorcycle drove speedily and disobediently and tried to flee away. Somehow we could be able to detain him at near PDGM High School morh on Manbazar Bandwan Pitch Road under Manbazar PS. This rough and negligence driving of driver would lead to an accident at any time. Any passerby could be injured by such activities. On being asked the above accused person could not be able to give any satisfactory answer for that movement on road and public place by such rough driving. On being asked he could not able to produce the valid documents in respect of said motor cycle. So I seized the said motor cycle bearing Regn No. JH02R/1689 (Red colour Yamaha) in between 20:35 hrs and 20:45 hrs after preparing proper seizure list duly signed by the witnesses. So I also arrested him at 20:55 hrs for rough and negligent driving and disobeying the order duly promulgated by public servant, after maintaining all rules of arrest, Issued memo of arrest.

So a specific case may be initiated against 1) Bhyam Chand Bauri S/O Madhu Bauri of village Madhupur PS- Manbazar, Dist- Purulia as per law and arrange for its investigation.
