Respected Sir,

With due respect I ASI Bachchu Ghosh, beg to submit before you that on 20/07/2022 at about 00.15 hrs while myself along with force 1) C/564 Prasad Majhi 2) C/805 Narayan Chandra Dhibar and 03) C/ 399 Kartick Mura were performing Night mobile duty vide Neturia PS CC No-2374/22 Dated-19/07/2022 at Perbelia Near Rahul Hotel on Purulia-Barakar Road (SH-5). I found one vehicle was coming from Raghunathpur side towards Dishergarh Ghat side with driving at excessive speed. Police personnel, present their in proper Police uniform raised hand and also show the Stop light to directed him to stop the vehicle but he violated the Police Signal and endangering human life by rash and negligent driving of the vehicle which may cause accident to the road user any time due to negligent driving of the driver of vehicle having No. WB 37E-0155. After long chase we can able to apprehend him at Perbelia More. On interrogation he made incoherent statement at different time. After continuous interrogation he disclosed his identity as Samiul Molla S/O- Lt. Idrish Molla of Vill- Khanni, P.O- Lokepur, PS-Lokepur, Dist-Birbhum. On being asked he failed to produce any valid documents of the said vehicle. Hence, he violated the provision of Section 279 IPC/184 MV Act. So, I seized the vehicle having Regd. No- WB37E-0155 (Dumper) at 00.35 hrs to 00.45 hrs under proper seizure list duly signed by the witnesses and arrested the offending driver namely Samiul Molla S/O- Lt. Idrish Molla of Vill- Khanni, P.O- Lokepur ,PS-Lokepur, Dist-Birbhum at 00.55 hrs avoiding by all the procedure as laid down in Cr.P.C and the latest guide lines of the Apex Court and bring him along with the seized vehicle to PS and produce before OC, Neturia PS.

So, I pray before you that a specific case may kindly be registered against the accused driver namely Samiul Molla S/O- Lt. Idrish Molla of Vill- Khanni, P.O- Lokepur ,PS-Lokepur, Dist-Birbhum vehicle having Regd. No-WB37E-0155 committing offence U/S-279 IPC/184 MV Act.
