Respected Sir,

With due respect I, SI Shib Narayan Singh, beg to submit before you that on 24/07/2022 at about 18:25 hrs while myself along with force 1) C/159 Dinesh Sardar 2) C/399 Kartik Chandra Mura and 03) NVF/530 Dilip Singh Sardar were performing evening mobile duty vide Neturia PS CC No-2430/22 Dated-24/07/2022 at Parbelia Bazar on Purulia-Barakar Road (SH-5). I found one vehicle was coming from Raghunathpur side towards Barakar side with driving in excessive speed. Police personnel, present there in proper Police uniform raised hand and directed him to stop the vehicle but he violated the Police Signal and endangering human life by rash and negligently driving of the vehicle which may cause accident to the road user any time. After long chase we can able to apprehend him at Dishergarh Naka point. On interrogation he disclosed his identity as Jamshed Khan (37) S/O- Aas Mohammad Khan of Vill-Khanpur Mewan, PS-Kishangarh Bas, Dist-Alwar, Rajasthan, Mob-7891757781. On being asked he failed to produce any valid documents of the said vehicle. Hence he violated the provision of Section 279 IPC/184 MV Act. So, I seized the vehicle having Regd. No- RJ 14GJ/6501 under proper seizure list duly signed by the witnesses and arrested the above noted offending driver avoiding by all the procedure as laid down in Cr.P.C and the latest guide lines of the Apex Court.

So I pray before you that a specific case may kindly be registered against the accused driver namely Jamshed Khan (37) S/O- Aas Mohammad Khan of Vill-Khanpur Mewan, PS-Kishangarh Bas, Dist-Alwar, Rajasthan, Mob-7891757781 (Driver of vehicle having Regd. No- RJ 14GJ/6501) committing offence U/S-279 IPC/184 MV Act.
