Sub:- Complain for starting a specific case .

Sir,

In producing herewith one seized tractor POWERTRAC 439 RDX having registration No- WB 55B/5751 along with trolley loaded with sand approx 100 Cft. under proper seizure list. I beg to submit that I, ASI Dhaneswar Mahato along with C/174 Tapandas Bauri and C/564 Prasad Majhi all are of Neturia PS were performing day mobile duty vide Neturia PS GD No- 1335 Dt. 28.07.22 & CC No- 2469/22 Dt. 28.07.22 and at about 15:35 hrs received a credible source information that one Tractor was coming from Chinakuri Ghat side towards Sarbari side loaded with sand illegally. I immediately intimated to you over phone and acquainted you about the information and you directed me to work out the information. As per your direction I along with force immediately started to move towards Chinakuri Ghat side. At about 15:55 hrs while we reached at Chinakuri More and found that one tractor is coming from Chinakuri Ghat side and stopped about 75/80 meter away from us and one person seems to be the driver of the tractor got down from the vehicle and started running towards jungle side. We chased the person but in spite of hot chase he managed to flee away. We searched the surrounding area to find out the person but failed to trace out him. On search we found that the vehicle (Tractor) registration number WB 55B/5751 has been loaded with sand approx 100 Cft.

So, there is reason to believe that the driver and registered owner of the vehicle have collected the said sand either by theft or by any fraudulent means and after hatching a criminal conspiracy, they were trying to dispose of the same sand in a clandestine manner to Sarbari village side knowing it to be stolen.

Accordingly, I seized the Tractor having registration number WB 55B/5751 along with trolley, loaded with sand approx 100 C.Ft. under proper seizure list duly signed by witnesses. So, the driver and registered owner of the tractor have committed offence U/S- 379/411/414/120B IPC & 21 (1) (4) Mines and Minerals (Development and Regulation) Act-1957.

Under the above fact and circumstances a specific case may kindly be started against driver and registered owner of the above noted seized tractor U/S- 379/411/414/120B IPC & 21 (1) (4) Mines and Minerals (Development and Regulation) Act-1957 and arrange for its investigation.
